CONSENT AGREEMENT

Region 8 of the United States Environmental Protection Agency (EPA) and Hoyt's Towing, Inc., (Respondent), by their undersigned representatives, agree as follows:

1. On December 29, 2015, the EPA issued a Complaint, Compliance Order and Notice of Opportunity for Hearing (Complaint and Compliance Order) under section 3008(a) of the Resource Conservation and Recovery Act (RCRA), 42 U.S.C. § 6928(a), alleging that the Respondent violated certain regulations promulgated pursuant to RCRA, 42 U.S.C. §§ 6901-6991, specifically 40 C.F.R. sections 262.11 and 279.22. The Complaint and Compliance Order proposed that the Respondent pay an administrative penalty for its violations pursuant to sections 3008(a)(3) and (g) of RCRA, as modified by the Debt Collection Improvement Act of 1996, and the Civil Monetary Penalties Inflation Adjustment Rule, 40 C.F.R. Part 19, of up to \$37,500.00 per day per violation of Subchapter III of RCRA.
2. On or about May 6, 2016, Respondent met its obligations under the Complaint and Compliance Order to take certain clean up measures and to submit documentation upon completion to show that the Respondent is now in compliance with 40 C.F.R. sections 262.11 and 279.22.
3. The Respondent admits the jurisdictional allegations and neither admits nor denies the specific factual allegations of the Complaint and Compliance Order.

4. The Respondent waives its right to contest the allegations in the Complaint and Compliance Order and to appeal any final order (Final Order) that an EPA Regional Judicial Officer may issue to approve this consent agreement (Agreement).

5. This Agreement, upon incorporation into a Final Order, is binding upon the EPA, the Respondent, and the Respondent's successors and assigns. Any change in ownership or corporate status of the Respondent, including, but not limited to, any transfer of assets or real or personal property, shall not alter the Respondent's responsibilities under this Agreement.

6. The Respondent agrees to pay a civil penalty in the amount of one hundred and fifty dollars (\$150.00) in the manner described below:

- a. Payment shall be in a single payment of one hundred and fifty dollars (\$150.00) due no later than 30 calendar days from the date of the Final Order. If the due date for the payment falls on a weekend or federal holiday, then the due date is the next business day. The date the payment is made is considered to be the date processed by U.S. Bank, as described below. Payment must be received by 11:00 a.m. Eastern Time to be considered as received that day.
- b. The payment shall be made by remitting a check or making an electronic payment, as described below. The check or other payment shall designate the name and docket number of this case, be in the amount stated in part "a," above, and be payable to "Treasurer, United States of America." The payment shall be remitted as follows:

- d. If the payment is not received by the specified due date, interest accrues from the date of the Final Order, not the due date, at a rate established by the Secretary of the Treasury pursuant to 31 U.S.C. § 3717 and will continue to accrue until payment in full is received (e.g., on the 1st late day, 30 days of interest will have accrued).
- e. A handling charge of fifteen dollars (\$15) shall be assessed the 31st day from the date of the Final Order, and for each subsequent 30-day period that the debt, or any portion thereof, remains unpaid. In addition, a 6% per annum penalty shall be assessed on any unpaid principal amount if payment is not received within 90 days of the due date. Payments are first applied to outstanding handling charges, second to penalty assessments, third to accrued interest, and then to the outstanding principal amount.
- f. The Respondent agrees that the penalty shall never be claimed as a federal or other tax deduction or credit.

7. Nothing in this Agreement shall relieve the Respondent of the duty to comply with the Act and any regulation, order, or permit issued pursuant to the Act.

8. Any failure by the Respondent to comply with this Agreement shall constitute a breach of this Agreement and may result in referral of the matter to the United States Department of Justice for enforcement of this Agreement and such other relief as may be appropriate.

9. Nothing in this Agreement shall be construed as a waiver by the EPA or any other federal entity of its authority to seek costs or any appropriate penalty associated with any collection action instituted as any failure by the Respondent to comply with this Agreement.

10. The undersigned representative of the Respondent certifies that he/she is fully authorized to enter into and bind the Respondent to this Agreement.


11. The parties agree to submit this Agreement to the appropriate EPA regional judicial officer, with a request that it be incorporated into a Final Order.

12. Each party shall bear their own costs and attorney's fees in connection with this matter.

13. This Agreement, upon incorporation into a Final Order and full satisfaction by the parties, shall be a complete and full resolution of the Respondent's liability for federal civil penalties for the violations and facts alleged in the Complaint and Compliance Order.
