Amendment to Consent Agreement and Final Order

1. This amendment modifies paragraphs 61 and 86 of the above-captioned **Consent Agreement and Final Order (CAFO)** which was filed with the Regional Hearing Clerk on August 30, 2018. Except as specifically set forth herein, all provisions of the August 30, 2018 CAFO shall remain in full force and effect.

2. Paragraph 61 of the original CAFO filed on August 30, 2018, is replaced as follows:

Diesel emission-reduction projects. SPPRC will undertake the following projects in the Minneapolis-St. Paul, Minnesota metropolitan area for at least \$271,200, for all the following projects combined.

- a. TC&W Auxiliary Power Unit Replacement. This project will replace outmoded locomotive engines.
- b. Spectro Alloys (or comparable) Loaders. These projects will replace outmoded loader engines.
- c. Magnolia Blossom Cruise Boat Re-power. This project will replace diesel-fired motive power on the Magnolia Blossom, including outmoded engines and associated transmissions.
- d. Bailey Nursery Loader Replacement. This project will replace an outmoded loader.

SPPRC shall undertake this SEP by arranging for a qualified contractor to carry out the referenced projects.

3. Paragraph 86 of the original CAFO filed on August 30, 2018, is replaced as follows:


This CAFO, filed with the Regional Hearing Clerk on August 30, 2018, as amended by the Amendment to Consent Agreement and Final Order, constitutes the entire agreement between the parties.

4. Each person signing this amendment to consent agreement certifies that he or she has the authority to sign for the party whom he or she represents and to bind that party to its terms.


