This 2<sup>nd</sup> addendum to the Administrative Order (Order) issued November 24, 2008, to you as owner of the Gramma Ruby's Public Water System (the system), approves your February 2, 2011 request via e-mail for an extension for submitting a compliance plan and schedule for bringing the system into compliance with the nitrate maximum contaminant level (MCL). This letter serves to incorporate into the Order the new date of March 13, 2011 as the deadline for the compliance plan and schedule. This new deadline will be an enforceable part of the Order.

Please note that EPA expects this deadline to be met. If unexpected events occur that are beyond your control and that may prompt you to request an extension of these deadlines, you will be responsible for notifying EPA well in advance of the deadline dates.
