
THIRD JOINT MOTION TO EXTEND TIME FOR CONDUCT OF HEARING

Respondent Parker Solvents Company, Inc., received on March 30, 2021, the U.S. Environmental Protection Agency's ("EPA") Initial Administrative Order in this matter. On April 21, 2021, EPA received Respondent's Response to Initial Administrative Order and Request for Hearing. On May 11, 2021, the Regional Judicial Officer ("RJO") granted Respondent's and EPA's ("the Parties") first Motion to Extend Time for Conduct of Hearing ("First Joint Motion") until July 12, 2021, to provide a period for good faith settlement negotiations. On July 12, 2021, RJO granted the Parties' second Motion to Extend Time for Conduct of Hearing ("Second Joint Motion") until October 12, 2021. Now, the Parties wish to continue in settlement negotiations and request a 90-day extension in order to provide an extended period for good faith settlement negotiations.
