

SETTLEMENT STATUS REPORT

1. On March 3, 2011, the Judge Barbara A. Gunning issued an order indicating that the parties hold a settlement conference before on or before March 18, 2011. This was the second such order, after Respondent's counsel failed to respond to Complainant's communications or comply with an initial order of November 30, 2010 instructing the Parties to hold a settlement conference before January 21, 2011. Respondent has been previously ordered to show cause as to why they failed to comply with the November 30, 2010 order. On March 10, 2011, Complainant's counsel wrote to Respondent's counsel advising him of his availability, and inviting him to participate in good-faith settlement discussions prior to the deadline. Exhibit 1. Counsel for Respondent did not communicate with Complainant's counsel until March 22, 2011, after the deadline had already passed.



2. The parties were able to hold brief settlement discussions on March 23, 2011, but were unable to reach any agreement in principle. Counsel for Respondents did not have settlement authority, but resolved to obtain firm commitments from Respondent demonstrating his client's return to compliance with the Clean Water Act and his permit. As of the date of this filing, the parties have not scheduled a follow-up conference. The parties feel that additional discussions, if held in short order, may prove productive in reaching an agreed resolution to this matter.
