#### ORDER RESCHEDULING STATUS REPORTS

On July 30, 2010, Complainant submitted an unopposed Motion for Extension of Time ("Motion"). In the Motion, Complainant requests a 30-day extension of all deadlines contained in the previous Scheduling Order, issued July 14, 2010. The Motion states that counsel for Complainant will be out of the office from August 6 through August 27, the date on which the second Status Report is due. The Motion also states that Respondent has recently submitted additional Supplemental Environmental Project ("SEP") proposals and additional time is necessary to review these proposals.

Some extension to allow for counsel's extended absence is appropriate, however a uniform 30-day extension of all dates would prolong this matter into its eighth month and is not necessary based on the reasons cited in the Motion. Accordingly, it is **ORDERED** that the case management schedule be amended as follows:

- Second Status Report due September 20, 2010,
- First Conference Call on Wednesday, October 15, 2010, at 2pm (Eastern Time),
- Third Status Report due November 12, 2010.
