
ORDER GRANTING COMPLAINANT'S MOTION FOR EXTENSION OF TIME  
TO FILE RESPONSE TO MOTION TO DISMISS

After the Complaint was filed in this matter, Respondent filed an Answer to the Complaint and a Motion to Dismiss and Brief in Support on November 17, 2009. On November 25, 2009, Complainant, EPA Region 8, filed a Motion for Extension of Time to File a Response to Motion to Dismiss and Brief in Support, noting that under the Rules of Practice, 40 C.F.R. § 22.16(b), the response to the motion to dismiss is due on December 4, 2009, and requesting a one week extension of time, until December 11, to file the response.

The extension is requested on the basis of the Thanksgiving holiday and the absence of key individuals necessary for preparation of the response. Complainant's counsel states that she has previously scheduled travel away from the office, and that Respondent's attorney indicated that he would not object to the extension of time. The Motion indicates that Respondent does not object to the requested extension.

Good cause exists for the granting of the Motion in that it is in the interest of the parties and judicial economy for the parties to be able to adequately prepare responses to motions. A hearing in this case has not been scheduled, and therefore no prejudice will result from a brief delay.

The Motion for an Extension of Time to File Response to Respondent's Motion to Dismiss is hereby **GRANTED**. The Complainant shall have until **December 11, 2009** to file its response to the Respondent's Motion to Dismiss.
