COMES NOW COMPLAINANT, the Director of the Compliance Assurance and Enforcement Division, United States Environmental Protection Agency, Region 6, by and through its attorney, submits this Motion to Withdraw Complaint Without Prejudice ("Motion"), pursuant to 40 C.F.R. § 22.14(d). In support thereof, Complainant states the following:

- Complainant filed the Administrative Complaint ("Complaint") in this matter on December
 21, 2011. The Complaint alleged that Morningstar Minerals Corporation ("Respondent") discharged
 pollutant-laden storm water associated with industrial activity from the facility site ("facility").
 - 2. Respondent filed an Answer to the Complaint on March 19, 2012.
- On or about April 10, 2012, Respondent provided Complainant with a photo outlining the boundaries of a berm between the facility and the Animas River
- A follow up inspection conducted on May 3, 2012 confirmed the placement of the berm as well as ditches preventing storm water from entering the Animas River.
- 5. Based upon information provided by Respondent and additional information provided by the follow up inspection, Complainant believes that Respondent has substantially remedied the violations alleged in the Complaint. Therefore, Complainant believes it is not in the public interest to continue to prosecute this case.
- Respondent has stated it does not object to this Motion to Withdraw Complaint Without
 Prejudice.
