Description: The U.S. Environmental Protection Agency (EPA), Region 5 provides this notice of the issuance of a Consent Agreement and Final Order (CAFO) to Joseph L. Bollig and Sons, Inc. (Respondent) for an alleged violation of Section 301 of the Clean Water Act. EPA has alleged in the CAFO that in 2008-2009, Joseph L. Bollig and Sons, Inc., a private corporation doing business in the State of Wisconsin, was hired by the Mauston-New Lisbon Union Airport (Airport) to perform filling of an approximately 0.5 acre portion of a 7-acre wetland area on Airport property. The filling activity was not authorized by a Department of the Army (Corps) permit, under Section 404 of the CWA, 33 U.S.C. § 1344. The filling activities occurred in a wetland that drains to a 1-mile long unnamed tributary to the Lemonweir River (a historical Traditional Navigable Water), which in turn enters the Wisconsin River, an interstate water body. Therefore, the abovementioned wetlands are subject to federal jurisdiction under the CWA.

Description: The U.S. Environmental Protection Agency (U.S. EPA), Region 5, is providing this notice of its intent to file a Consent Agreement and Proposed Final Order (Proposed CAFO) against Logeman Brothers Farm (Respondent) for violations of the Clean Water Act. This Proposed CAFO will settle U.S. EPA's allegations that the Respondent violated the Clean Water Act by discharging pollutants without a permit into a water of the United States. Respondent operates a concentrated animal feeding operation in Massac County, Illinois. In the proposed CAFO, U.S. EPA alleges that Respondent discharged pollutants from its operation to an unnamed tributary of Gurley Ditch which flows through a series of ditches and ultimately into the Ohio River. The U.S. EPA and Respondent have agreed in principle that Respondents will pay a civil penalty of \$3,200 to resolve these violations.

Description: The U.S. Environmental Protection Agency (U.S. EPA), Region 5, is providing this notice of its intent to file a proposed Consent Agreement and Final Order (CAFO) against the Muskegon Development Corporation (Respondent) for violations the Safe Drinking Water Act (SDWA). This proposed CAFO will settle civil violations alleging that the Respondent converted four oil production wells in Michigan into Class 2 Underground Injection Control (UIC) wells before the required Federal UIC permits were issued. The U.S. EPA and Respondent have agreed in principle that Respondent will pay a civil penalty of \$16,000.
