Dear Ms. White:

On March 8, 2011, the U.S. Environmental Protection Agency (EPA) issued an Administrative Order (Order), which was amended on August 5, 2011, to Kennington Springs Pipeline, Inc. (Respondent), citing violations of the National Primary Drinking Water Regulations (NPDWRs), 40 C.F.R. part 141, and, among other things, directing Respondent to submit a plan for coming into compliance with the maximum contaminant level (MCL) for total coliform.

Our records indicate that Respondent continues to be in violation of the Order. A schedule submitted by Respondent to ensure consistent compliance with the total coliform MCL, and approved by the EPA on February 13, 2014 (addendum #4), required that a completed water district formation petition application be submitted to the Lincoln County Clerk by March 7, 2014. Respondent notified the EPA via email on September 16, 2014, that the paperwork submitted by Respondent for district formation was insufficient and that Respondent was trying to get it correct and resubmitted. Although it is now more than 8 months after the completed application was to have been submitted, the EPA has still not been notified that this has been accomplished. All other actions that were to have been accomplished through November 2014 have also not been completed. If not already accomplished, a complete and accurate application for district formation must be submitted to the Lincoln County Clerk immediately. A new schedule for completion must also be submitted to the EPA immediately.

The EPA is considering additional enforcement action as a result of non-compliance with the Order. Violating an Administrative Order may lead to (1) a penalty of up to \$37,500 per day per violation of the Order, and/or (2) a court injunction ordering compliance.
