

The Director of the Compliance Assurance and Enforcement Division, United States Environmental Protection Agency, Region 6 (“Complainant”), respectfully requests that the Regional Judicial Officer modify the third Extension of Deadline for Filing an Answer and Requesting a Hearing granted on September 25, 2013. In light of the emergency furlough lasting from October 1 – 16, 2013, Complainant requests additional time to review and make any necessary changes to a mutually agreeable Consent Agreement and Final Order (“CAFO”). The Regional Judicial Officer granted a third extension on September 25, 2013, extending the deadline to October 31, 2013. Since that time, a lapse in federal appropriations resulted in an emergency furlough of nonessential government employees, which completely stalled discussions between Complainant and Respondent.

Accordingly, Complainant respectfully requests sixteen (16) additional days to finalize and execute a CAFO. This modification of the extension provides a deadline to

file an Answer and Request a Hearing of November 16, 2013. Complainant consulted Respondent in the preparation of this motion, and Respondent concurs.
