ORDER TO SHOW CAUSE

By Order dated October 8, 2009, Respondents were directed to file their prehearing exchanges on or before December 11, 2009. On December 8, 2009 Respondents, appearing *pro se*, submitted a Motion for an Extension of Time, seeking an additional sixty (60) days, until February 10, 2010, to file their prehearing exchanges. By Order dated December 10, 2009, for good cause shown, such lengthy extension was granted. On February 9, 2010, the Respondents filed a Motion for an Additional Extension of Time seeking *another* 60 day extension. By Order dated February 16, 2010, Respondents were granted an additional 30 days, until March 16, 2010, to file their Prehearing Exchanges. **To date, however, Respondents have not filed their Prehearing Exchanges.** Section 22.17 (a) of the Consolidated Rules of Practice Governing The Administrative Assessment of Penalties provides that a party may be found in default for failing to comply with a Prehearing Order.

Therefore, it is hereby **ORDERED** that on or before **APRIL 2, 2010**, Respondents show good cause for why they failed to submit their prehearing exchanges in a timely manner as required by the Prehearing Orders of this Tribunal and why a Default should not be entered against them. **Failure to timely respond to this Order in a timely manner will result in the entry of default without further notice.**


