COMES NOW the Complainant, United States Environmental Protection Agency Region 7 (Complainant or EPA) and avers and moves as follows:

- 1. Complainant agreed with the Missouri Department of Natural Resources that MDNR would pursue the enforcement case against Respondents TNT General Contracting, Inc. (TNT) and the Gary and Carol Trump Trust (the Trust).
- 2. Based on an analysis by Complainant's contractor, Industrial Economics of Cambridge, Massachusets, Complainant has determined that Respondent Webb Minerals.

LLC (Webb) has an extremely limited ability to pay for penalties and injunctive relief in this matter.

- 3. Complainant agreed with counsel for Webb that if Webb would pay for the proper removal of the remaining waste from the TNT facility, Complainant would dismiss the matter with respect to Webb. Prior to that referral and during the ADR period, discussions between Counsel for TNT
- 4. Counsel for Webb has provided documentation showing that Webb has completed the removal of the materials from the TNT facility.
- 5. Counsel for MDNR has provided documentation that the administrative agreement among MDNR, TNT and the Trust has been signed and filed.
- 6. Since all of the conditions for dismissal have been met to EPA's satisfaction, Complainant therefore moves that this Court dismiss this matter in its entirety.
