ORDER REGARDING SCHEDULING

Pursuant to a conference call held with the parties on June 18, 2009, this Order memorializes certain agreed to matters of scheduling in this proceeding and the companion case, Docket Number, RCRA 05-2008-0006. As these two cases already have been delayed in order to accommodate discovery, further extensions will be disfavored.

Motions for Accelerated Decision will be filed by July 2, 2009, with Responses due by July 31st. Any Reply is to be filed by August 12th. The hearings will start on October 13 and continue as necessary through October 16th. Because the two cases have many common issues, the parties and the Court will fashion a procedure to streamline the evidentiary hearings. While it appears very unlikely that the hearings would last beyond October 16th, the parties agreed to leave their schedules open for the following week, should additional time be necessary. The hearings will be held in Toledo, Ohio, unless a suitable courtroom can not be secured. In that event, the Court will find a courtroom as near to Toledo as possible for the dates listed above


