Respondent XTO Energy Inc. ("XTO") hereby files this Unopposed Motion for Extension of Time to file its Answer to the Complaint and Notice of Opportunity for Hearing ("Complaint") filed by the Environmental Protection Agency ("EPA") in the above-captioned matter.

XTO respectfully requests an extension until <u>October 25, 2023</u>, to file its Answer in this matter. In support of this request, XTO states as follows:

- 1. EPA filed its Complaint with the Regional Hearing Clerk on April 7, 2023.
- 2. XTO was served with the Complaint, via certified mail, on April 18, 2023.
- 3. The original deadline for XTO to file an Answer to the Complaint was May 18, 2023.
- 4. The Regional Judicial Officer extended the deadline for XTO to file its Answer until September 25, 2023, to facilitate settlement discussions between EPA and XTO.
 - 5. XTO and EPA recently finalized a mutual settlement.
- 6. EPA filed the executed Consent Agreement and supporting documents for the Regional Judicial Officer's review on September 21, 2023.
- 7. There is good cause for the requested extension: The extension is necessary to provide the Regional Judicial Officer sufficient time to review the proposed settlement between XTO and EPA and the Parties' request that Regional Judicial Officer approve the Consent Agreement and issue a Final Order.

- 8. <u>The requested extension will not prejudice EPA</u>: EPA and XTO have agreed to a mutual settlement. EPA does not oppose the motion; and the underlying mechanical-integrity issue identified in the Complaint has been addressed.
- 9. The requested extension is timely filed: This Unopposed Motion for Extension of Time is being filed "sufficiently in advance of the due date" for XTO to file its Answer as required by 40 C.F.R. § 22.7(b).
