ADMINISTRATIVE ORDERS PREVIOUSLY ISSUED ARE TERMINATED AND SUPERSEDED BY THE ANACONDA SMELTER SITE CONSENT DECREE

I. Orders Issued to the Atlantic Richfield Company for Remedial Actions at the Anaconda Smelter Superfund Site Between 1994 and 2016:

1. Administrative Order on Consent for Time Critical Removal Action, Docket No. CERCLA 08-91-26, issued September 20, 1991. This order required the Atlantic Richfield Company (AR) to complete a time critical removal action at the Teressa Ann Terrace, Elkhorn Apartments, and Cedar Park Homes residential Area within the Community Soils Operable Unit, OU6, of the Anaconda Smelter Superfund Site. This order is hereby terminated and superseded by the requirements of the Anaconda Smelter Site Consent Decree, Civil Action No. CV89-039-BU-SHE dated December 16, 2022.

2. Administrative Order for Remedial Design/Remedial Action, Docket No. CERCLA 08-94-08, issued April 7, 1994. This order required the AR to complete remedial work at the Old Works/East Anaconda Development Area Operable Unit, OU 7, of the Anaconda Smelter Superfund Site. This order is hereby terminated and superseded by the requirements of the Anaconda Smelter Site Consent Decree, Civil Action No. CV89-039-BU-SHE dated December 16, 2022.

3. Administrative Order for Remedial Action, Docket No. CERCLA-08-2001-01 issued on December 11, 2000. This Order required AR to complete remedial work at the Anaconda Ponds Remedial Design Unit (RDU) or RDU 4 which is within the Anaconda Regional Water, Waste, and Soils Operable Unit (ARWWS OU), OU 4, of the Anaconda Smelter Superfund Site. This Order is hereby terminated and superseded by the requirements of the Anaconda Smelter Site Consent Decree, Civil Action No. CV89-039-BU-SEH dated December 16, 2022.

4. Administrative Order for Remedial Action, Docket No. CERCLA-08-2002-07, issued June 7, 2002. This order required AR to complete remedial work at the Triangle Waste Area (TWA) of the Opportunity Ponds RDU, RDU 8, within the ARWWS OU, OU 4, of the Anaconda Smelter Superfund Site. This Order is hereby terminated and superseded by the requirements of the Anaconda Smelter Site Consent Decree, Civil Action No. CV89-039-BU-SEH dated December 16, 2022.

5. *Administrative Order for Remedial Action*, Docket No. CERCLA-08-2002-08, issued September 14, 2002. This order required AR to complete remedial work at the Residential Soils RDU within the Community Soils OU, OU 16, of the Anaconda Smelter Superfund Site. This Order is hereby terminated and superseded by the requirements of the Anaconda Smelter Site Consent Decree, Civil Action No. CV89-039-BU-SEH dated December 16, 2022.

6. *Administrative Order for Remedial Action*, Docket No. CERCLA-08-2002-09, issued September 9, 2002. This order required AR to complete remedial work at the Aspen Hills Loop Track Area (AHLT), which is within Smelter Hill Uplands RDU, RDU 13, and Smelter Hill Facilities RDU, RDU 14, which are both within the ARWWS OU, OU4, of the Anaconda Smelter Superfund Site. This Order is hereby terminated and superseded by the requirements of the Anaconda Smelter Site Consent Decree, Civil Action No. CV89-039-BU-SEH, dated December 16, 2022.

7. Administrative Order for Remedial Action, Docket No. CERCLA-08-2002-10, issued September 23, 2002. This order required AR to complete remedial work at a portion of Area 4 of the Stucky Ridge RDU, RDU 1, within the ARWWS OU, OU 14, of the Anaconda Smelter Superfund Site. This Order is hereby terminated and superseded by the requirements of the Anaconda Smelter Site Consent Decree, Civil Action No. CV89-039-BU-SEH dated December 16, 2022.

8. *Administrative Order for Remedial Action*, Docket No. CERCLA-08-2005-0007, issued August 5, 2005. This order required AR to perform remedial work at the West Galen

Expansion Area Number 2, within the North Opportunity RDU, RDU 7, which is within the ARWWS OU, OU 14, of the Anaconda Smelter Superfund Site. This Order is hereby terminated and superseded by the requirements of the Anaconda Smelter Site Consent Decree, Civil Action No. CV89-039-BU-SEH dated December 16, 2022.

9. Administrative Order for Remedial Action, Docket No. CERCLA-08-2007-0008, issued on June 5, 2007. This order required AR to complete remedial work at the South Opportunity Uplands RDU, RDU 6, within the ARWWS OU, OU 14, of the Anaconda Smelter Superfund Site. This Order is hereby terminated and superseded by the requirements of the Anaconda Smelter Site Consent Decree, Civil Action No. CV89-039-BU-SEH dated December 16, 2022.

10. Administrative Order for Remedial Action, Docket No. CERCLA-08-2008-0009, issued September 22, 2008. This order required AR to complete remedial work at the North Opportunity Uplands RDU, RDU 7, which is within the ARWWS OU, OU 14, of the Anaconda Smelter Superfund Site. This Order is hereby terminated and superseded by the requirements of the Anaconda Smelter Site Consent Decree, Civil Action No. CV89-039-BU-SEH dated December 16, 2022.

11. Administrative Order for Remedial Action, Docket No. CERCLA-08-2010-0004, issued September 9, 2010. This order required AR to complete remedial work at the Fluvial Tailings RDU, RDU 9, which is within the ARWWS OU, OU 14, of the Anaconda Smelter Superfund Site. This Order is hereby terminated and superseded by the requirements of the Anaconda Smelter Site Consent Decree, Civil Action No. CV89-039-BU-SEH dated December 16, 2022.

12. Administrative Order for Remedial Action, Docket No. CERCLA-08-2011-0009, issued June 2, 2011. This order required AR to complete remedial work at the Smelter Hill Facilities Area RDU, RDU 14, which is within the ARWWS OU, OU 14, of the Anaconda Smelter Superfund Site. This Order is hereby terminated and superseded by the requirements of the Anaconda Smelter Site Consent Decree, Civil Action No. CV89-039-BU-SEH dated December 16, 2022.

13. Administrative Order for Remedial Action, Docket No. CERCLA-08-2015-0010, issued September 24, 2015. This order required AR to complete remedial work at the Warm Springs Creek RDU, RDU 10, which is within the ARWWS OU, OU 14, of the Anaconda Smelter Superfund Site. This Order is hereby terminated and superseded by the requirements of the Anaconda Smelter Site Consent Decree, Civil Action No. CV89-039-BU-SEH dated December 16, 2022.

14. *Administrative Order for Remedial Action*, Docket No. CERCLA-08-2015-0011, issued September 24, 2015. This order required AR to complete remedial work at the Community Soils OU of the Anaconda Smelter Superfund Site. This Order is hereby terminated

and superseded by the requirements of the Anaconda Smelter Site Consent Decree, Civil Action No. CV89-039-BU-SEH dated December 16, 2022.

15. *Administrative Order for Remedial Action*, Docket No. CERCLA-08-2016-0005, issued June 17, 2016. This order required AR to complete remedial work at the Smelter Hill Uplands RDU, RDU 3, which is within the ARWWS OU, OU 14, of the Anaconda Smelter Superfund Site. This Order is hereby terminated and superseded by the requirements of the Anaconda Smelter Site Consent Decree, Civil Action No. CV89-039-BU-SEH dated December 16, 2022.
