Initial Case Status Conference Call - Scheduling Order

I have been designated to serve as the Agency neutral official in the aforementioned CERCLA lien matter and to preside over a meeting conducted in accordance with the U.S. Environmental Protection Agency's ("EPA") Supplemental Guidance on Federal Superfund Liens, OSWER Directive No. 9832.12-1a (July 29, 1993). The purpose of the meeting will be to determine whether the EPA has a reasonable basis to perfect a lien on the real property located at 2818-20 East Belgrade Street, Philadelphia, Pennsylvania ("Belgrade Transformer Site"), under Section 107(1) of the Comprehensive Environmental Response, Compensation and Liability Act of 1980 ("CERLCA"), as amended, 42 U.S.C. § 9607(1). The meeting is being held pursuant to a request filed on May 21, 2018 with EPA Region III by Mr. John F. Joyce, Jr., the owner of the property.

The purpose of this letter is to schedule an initial case status conference call to address any questions you may have regarding the scope and nature of this proceeding and to assure that concerns the parties may have are properly addressed in a timely manner. I would also like to set during the call a
