

**ORDER TERMINATING ALTERNATIVE DISPUTE RESOLUTION  
PROCESS AND REQUESTING ASSIGNMENT OF CASE TO LITIGATION**

On July 8, 2008 an Order was issued initiating the Alternative Dispute Resolution (ADR), process and appointing the undersigned as a neutral. The Order provided that unless terminated earlier at the request of either party or an extension is granted, the ADR process would terminate on September 8, 2008. As allowed, an extension was granted until October 22, 2008 and then until November 12, 2008. As time under the ADR process has expired, it is recommended that the ADR process be terminated and that this case be reassigned by the Chief Judge to an Administrative Law Judge for litigation.
