
The U.S. Environmental Protection Agency (USEPA) has received two (2) distinct requests, the first within an R360 Environmental Solutions', September 6, 2013, Quarterly Progress Report and the second from a November 8, 2013, follow-up teleconference call between you and Mr. Randy Lamdin, the USEPA Project Manager for this R360-Calpet RCRA 7003 order. Specifically, as verbally agreed upon, R360 Environmental Solutions is requesting a RCRA 7003 order reporting modification from quarterly to semi-annually.

Based upon the terms of the RCRA 7003 order (RCRA-08-2012-0001), as amended, under XVII. OPPORTUNITY TO CONFER, AND MODIFICATION and subsequently under VII.E. REPORTING, per VII.E.4., the USEPA has conferred with the USFWS and the WDEQ and collectively determined that R360 Environmental Solutions can transition to submitting semi-annual progress reports, following the submittal of a fourth and last quarterly progress report. For continuity, the USEPA requests that this last quarterly progress report embrace the period from the second week of September through December 2013, due on January 10, 2014. The semi-annuals can cover January through June 2014 and July through December 2014, due on July 10, 2014, and January 10, 2015, respectively.

By this correspondence, for R360-Calpet, under XVII.B.-C., the USEPA is modifying this order, as amended, accordingly, to reflect semi-annual reporting vice quarterly reporting requirements, as stipulated above.
