Dear Mayor Feldmann:

On June 8, 2010, the US Environmental Protection Agency (EPA) issued an Emergency Administrative Order (the Order) ordering the Town of Dixon (the Town) to take various measures in response to the loss of pressure in the Town's drinking water distribution system.

The Order required the Town to issue a public notice and boil order, and to continue the notice until receiving notification from EPA to suspend it. This letter confirms the verbal notice provided by Lisa Kahn of EPA on June 12, 2010, that EPA hereby suspends the "Boil Order and Public Notice" section of the Order (page 2, paragraph 2), because the Town's water supply no longer presents an imminent and substantial endangerment.

This letter also serves as written notice that effective June 12, 2010, pursuant to the Order (page 3, paragraph 6), daily special purpose bacteriological and chlorine residual monitoring is no longer required and may now be reduced to weekly monitoring as verbally communicated to the Town by Lisa Kahn on June 12, 2010. This notice is based on total coliform monitoring conducted June 9-11, 2010, with each sample analyzed as total coliform negative and chlorine residual samples meeting acceptable levels. Weekly monitoring shall be conducted until the Town is notified in writing by EPA that bacteriological sampling may be returned to monthly and special purpose and chlorine residual sampling can be discontinued. All weekly special purpose monitoring results shall be reported to EPA by fax immediately upon receiving the results.

The remainder of the Order remains in effect.
