## MOTION REQUESTING EXTENSION OF TIME TO FILE RESPONDENT'S PREHEARING EXCHANGE

## TO THE HONORABLE PRESIDING OFFICER:

COMES NOW, respondent, TAPI Puerto Rico, Inc. ("TAPI"), through the undersigned attorneys, and very respectfully informs states and prays as follows:

- 1. The Prehearing Order ("Order") issued by Honorable Susan L. Biro, Administrative Law Judge for the case at bar, establishes the schedule by which the Parties should file the Prehearing Exchange. According to the Order, the Complainant was required to file its Prehearing Exchange by January 6, 2012. Twenty one (21) days later (i.e., January 27, 2012) TAPI is required to submit its Prehearing Exchange.
- 2. On January 5, 2012, Complainant filed a motion for extension of time to file the Prehearing Exchange, which we discussed with counsel for the Complainant and confirmed we had no objection to the same. Such motion was granted on January 6, 2012.
- 3. On January 11, 2012, Complainant filed its Prehearing Exchange. A copy was sent to the undersigned by ordinary certified mail only which was received on January 19, 2012.

On January 12, 2012, the undersigned, for reasons beyond her control, suffered a serious accident which required urgent medical care, immobilization and home confinement for a period of two (2) weeks. Today, the undersigned, who is the only attorney in the firm

familiar with the case and able to prepare TAPI's Prehearing Exchange, was able to come to

work for a limited time only, as per medical instructions.

5. In view of the foregoing, and considering that there is no undue delay, bad faith or dilatory motive, TAPI requests the Honorable Administrative Law Judge to grant

TAPI twenty one (21) additional days from this date to file its Prehearing Exchange.

6. We contacted Complainant's attorney by electronic correspondence and she

confirmed she has no objection to the present motion.

WHEREFORE, TAPI respectfully requests this Honorable Presiding Officer to take

notice of the aforementioned and, consequently, grant the extension of time requested herein

above, that is, until February 17, 2012 to file its Prehearing Exchange.
