The parties hereby file this Joint Status Report in the above-styled case. Counsel for Respondents has authorized Counsel for Complainant to sign and submit this Joint Status Report for the parties. EPA anticipates that it will be presenting the final Consent Agreement and Final Order (CAFO) to the Region 4 Regional Administrator for signature by the end of this week (March 9, 2012) or by no later than March 14, 2012. The exact date will depend on when the real estate closing occurs that will conclude the donation of property from Respondent Duvall Development Company to the U.S. Forest Service. The USFS has advised EPA that the transactional paperwork is in order and all signatures and filings should occur this week or next, barring any last minute glitches in the process. Assuming that the closing occurs this week or by the middle of next week, the Regional Administrator will sign the CAFO and this case will finally be resolved. As soon as the CAFO is finalized, EPA counsel will email a copy to the Court.
