Description: The U.S. Environmental Protection Agency (U.S. EPA), Region 5, is providing this notice of its intent to file a Proposed Consent Agreement and Final Order (Proposed CAFO) against Deere & Company (Respondent) for violations of the Clean Water Act. In 2005, Deere self-disclosed to U.S. EPA potential violations of the permit requirements promulgated under the Clean Water Act. This Proposed CAFO will settle civil violations alleging that the Respondent exceeded daily maximum categorical limits and monthly average categorical limits for metals in the effluent discharged from its facility in Moline, Illinois. The Proposed CAFO further alleges that the Respondent failed to submit semi-annual reports that described completely the nature and concentration of pollutants contained in its effluent. The U.S. EPA and Respondent have agreed in principle that Respondent will pay a civil penalty of \$99,000 to resolve these violations.
