I. STATUTORY AUTHORITY

1.1. This Consent Agreement is issued under the authority vested in the Administrator of the U.S. Environmental Protection Agency ("EPA") by Section 325 of the Emergency Planning and Community Right-to-Know Act ("EPCRA"), 42 U.S.C. § 11045.

1.2. Pursuant to Section 325 of EPCRA, 42 U.S.C. § 11045, and in accordance with the

"Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties,"

40 C.F.R. Part 22, EPA issues, and OSCCorp Inc., f.k.a. "Oberto Sausage Company"

("Respondent") agrees to issuance of, the Final Order attached to this Consent Agreement ("Final

Order").

II. PRELIMINARY STATEMENT

2.1. In accordance with 40 C.F.R. §§ 22.13(b) and 22.18(b), issuance of this Consent Agreement commences this proceeding, which will conclude when the Final Order becomes effective.

2.2. The Director of the Enforcement and Compliance Assurance Division, EPA
Region 10 ("Complainant") has been delegated the authority pursuant to Section 325 of EPCRA,
42 U.S.C. § 11045, to sign consent agreements between EPA and the party against whom an
administrative penalty for violations of EPCRA is proposed to be assessed.

2.3. Part III of this Consent Agreement contains a concise statement of the factual and legal basis for the alleged violations of EPCRA together with the specific provisions of EPCRA and the implementing regulations that Respondent is alleged to have violated.

III. <u>ALLEGATIONS</u>

3.1. Section 312 of EPCRA and the regulations at 40 C.F.R. Part 370, require the owner or operator of a facility that is required to prepare or have available a material safety data sheet for a hazardous chemical, under the Occupational Safety and Health Act of 1970, 29 U.S.C. § 651 *et seq.*, and which has a hazardous chemical present at any one time in an amount equal to or greater than a specified threshold quantity, to prepare and submit a Tier II emergency and hazardous chemical inventory form ("Tier II Form") to the appropriate local emergency planning committee ("LEPC"), state emergency response commission ("SERC"), and local fire department by March 1, containing data with respect to the preceding calendar year. The required data includes estimates of the average and maximum quantities of each hazardous chemical stored in excess of the threshold quantity. 40 C.F.R. § 370.42.

3.2. "Hazardous chemical," with certain exceptions, has the meaning given such term by the Occupational Safety and Health Act (OSHA) and its implementing regulations. EPCRA §§ 311(e) and 329(5). Pursuant to those regulations, "hazardous chemical" means any chemical which is classified as a physical hazard or a health hazard, a simple asphyxiant, combustible dust, pyrophoric gas, or hazard not otherwise classified. 29 C.F.R. § 1900.1200(c).

3.3. An "extremely hazardous substance" is a subset of "hazardous chemicals" and is defined at 40 C.F.R. § 370.66 as a substance listed in appendices A and B of 40 C.F.R. part 355.

3.4. 40 C.F.R. § 370.10(a)(1) provides that the threshold quantity that triggers reporting obligations under EPCRA Section 312 for an extremely hazardous substance is 500 pounds or more of the substance present at the facility at any one time.

3.5. 40 C.F.R. § 370.10(a)(2) provides that the threshold quantity that triggers reporting obligations under EPCRA Section 312 for a hazardous chemical that is not an extremely hazardous substance is 10,000 pounds or more of a hazardous chemical present at the facility at any one time, unless the hazardous chemical is gasoline or diesel fuel at a retail gas station.

3.6. Ammonia is a "hazardous chemical" and an "extremely hazardous substance" whose threshold quantity is 500 pounds.

3.7. Sulfuric Acid is a "hazardous chemical" and an "extremely hazardous substance" whose threshold quantity is 500 pounds.

3.8. Diesel is a "hazardous chemical" whose threshold quantity is 10,000 pounds.

3.9. Nitrogen is a "hazardous chemical" whose threshold quantity is 10,000 pounds.

3.10. Lead is a "hazardous chemical" whose threshold quantity is 10,000 pounds.

3.11. At all relevant times, Respondent owned or operated a business located at 7060 South 238th Street in Kent, Washington, that stored hazardous chemicals and extremely hazardous

substances and such location is a "Facility" within the meaning of EPCRA § 329(4).

3.12. At the relevant time, Respondent was the "owner or operator" of the Facility within the meaning of EPCRA § 312.

3.13. Respondent was required to have a material safety data sheet available pursuant to the Occupational Safety and Health Act of 1970, 29 U.S.C. § 651 *et seq.*

3.14. During calendar years 2015 and 2017, Respondent stored more than 500 pounds each of ammonia and sulfuric acid at the Facility and exceeded the threshold quantity for applicability of EPCRA § 312 reporting pursuant to 40 C.F.R. § 370.10(a)(1).

3.15. During calendar years 2015 and 2017, Respondent stored more than 10,000 pounds each of diesel, nitrogen and lead at the Facility and exceeded the threshold quantity for applicability of EPCRA § 312 reporting pursuant to 40 C.F.R. § 370.10(a)(2).

3.16. During calendar years 2015 and 2017, Respondent was subject to EPCRA Section 312 and was required pursuant to 40 C.F.R. § 370.45(a) to submit a Tier II Form to the LEPC, SERC, and local fire department by March 1, containing data with respect to the preceding calendar year.

3.17. Respondent failed to timely submit a Tier II Form to the LEPC, SERC, and local fire department for calendar year 2015 by March 1, 2016, in violation of EPCRA § 312 and 40 C.F.R. § 370.45(a).

3.18. Respondent failed to timely submit a Tier II Form to the LEPC, SERC, and local fire department for calendar year 2017 by March 1, 2018, in violation of EPCRA § 312 and 40 C.F.R. § 370.45(a).

3.19. Under Section 325 of EPCRA, 42 U.S.C. § 11045, and 40 C.F.R. Part 19, EPA may assess a civil penalty of not more than \$55,907 for each such violation.

IV. TERMS OF SETTLEMENT

4.1. Respondent admits the jurisdictional allegations of this Consent Agreement.

4.2. Respondent neither admits nor denies the specific factual allegations contained in this Consent Agreement.

4.3. EPA has determined and Respondent agrees that an appropriate penalty to settle this action is \$45,175 (the "Assessed Penalty").

4.4. Respondent agrees to pay the Assessed Penalty within 30 days of the effective date of the Final Order.

4.5. Payments under this Consent Agreement and the Final Order may be paid by check (mail or overnight delivery), wire transfer, ACH, or online payment. Payment instructions are available at: <u>http://www2.epa.gov/financial/makepayment</u>. Payments made by a cashier's check or certified check must be payable to the order of "Treasurer, United States of America" and delivered to the following address:

4.7. If Respondent fails to pay any portion of the Assessed Penalty in full by its due date, the entire unpaid balance of the Assessed Penalty and accrued interest shall become immediately due and owing. If such a failure to pay occurs, Respondent may be subject to a civil action under Section 325(f)(1) of EPCRA, 42 U.S.C. § 11045(f)(1), to collect any unpaid penalties, together with interest, handling charges, and nonpayment penalties, as set forth below.

4.8. If Respondent fails to pay any portion of the Assessed Penalty in full by its due date, Respondent shall also be responsible for payment of the following amounts:

a. Interest. Pursuant to 31 U.S.C. § 3717(a)(1), any unpaid portion of the

Assessed Penalty shall bear interest at the rate established by the Secretary of the Treasury from the effective date of the Final Order contained herein, provided, however, that no interest shall be payable on any portion of the Assessed Penalty that is paid within 30 days of the effective date of the Final Order contained herein.

b. Handling Charge. Pursuant to 31 U.S.C. § 3717(c)(1), a monthly handling charge of \$15 shall be paid if any portion of the Assessed Penalty is more than 30 days past due.

c. Nonpayment Penalty. Pursuant to 31 U.S.C. § 3717(e)(2), a nonpayment penalty of 6% per annum shall be paid on any portion of the Assessed Penalty that is more than 90 days past due, which nonpayment shall be calculated as of the date the underlying penalty first becomes past due.

4.9. The Assessed Penalty, including any additional costs incurred under Paragraph 4.8, represents an administrative civil penalty assessed by EPA and shall not be deductible for purposes of federal taxes.

4.10. The undersigned representative of Respondent certifies that he or she is authorized to enter into the terms and conditions of this Consent Agreement and to bind Respondent to this document.

4.11. The undersigned representative of Respondent also certifies that, as of the date of Respondent's signature of this Consent Agreement, the violation(s) alleged in Paragraphs 3.17 and 3.18 of this Consent Agreement have been corrected.

4.12. Except as described in Paragraph 4.8, each party shall bear its own costs and attorneys' fees in bringing or defending this action.

4.13. For purposes of this proceeding, Respondent expressly waives any affirmative defenses and the right to contest the allegations contained in this Consent Agreement and to appeal the Final Order.

4.14. The provisions of this Consent Agreement and the Final Order shall bind Respondent and its agents, servants, employees, successors, and assigns.

4.15. Respondent consents to the issuance of any specified compliance or corrective action order, to any conditions specified in this consent agreement, and to any stated permit action.
