This letter is to inform you of the U.S. Environmental Protection Agency's decision to close above-referenced Administrative Order (Order), Docket No. SDWA-08-2010-0047, issued to Lambert County Sewer and Water District (District) as owner and/or operator of the Lambert County Sewer and Water District Public Water System on June 28, 2010. The EPA has determined that the District complied with the requirements of the Order and, therefore, we will close it at this time.

Please be aware that the District is still required to comply with the National Primary Drinking Water Regulations at 40 C.F.R. part 141. Violation of the drinking water regulations may result in a court-imposed injunction and/or penalties of up to \$37,500 per day of violation.
