This Addendum to the Administrative Order issued April 17, 2008, to the Town of LaBarge (the Town), owner and operator of the Town of LaBarge water system (the system), approves the compliance schedule, including the final completion date, for treatment outlined in the August 15, 2008 letter from Dave Noel of Forsgren Associates Inc. on behalf of the Town. EPA was notified in a December 11, 2009, e-mail from Mr. Noel that the engineering plans and specifications have been approved by the State of Wyoming and installation of the membrane filtration water treatment plant will be completed by August 31, 2010. Additionally, Mr. Noel stated that the Town has completed the construction bidding process and awarded the contract to Hydro Construction.

The effect of this Addendum is to incorporate the August 31, 2010 final deadline for treatment installation into the Administrative Order. This deadline will be enforceable as if it were part of the Administrative Order itself. The Town is responsible for notifying EPA of any delays with regard to this schedule. This Addendum is effective upon the date received.

Please be advised that the Town is required to comply with all provisions of the Administrative Order. Penalties for failing to comply are set forth in the Order.
