Dear Mr. Bassett:

On November 7, 2008, the U.S. Environmental Protection Agency (EPA) issued an Emergency Administrative Order (Order) under section 1431 of the Safe Drinking Water Act (the Act), 40 U.S.C. § 300i, to the Osmond Pipeline Company public water system (the System). This letter confirms the verbal notice provided to you, operator of the System, by Shawn McCaffrey of EPA on November 14, 2008 regarding the recision of the public notification, boil order, daily updates, and alternate water source requirements under the Order. Additionally, this letter serves as written notice that daily bacteriological monitoring shall be continued until you are notified by EPA that sampling may be reduced to weekly. The System is required to comply with all other provisions of the Order. Penalties for failing to comply are set forth in the Order.

At this time, we are also extending the timeframe you have to submit a compliance plan and schedule as described on page 4 of the Order. This plan and schedule is now due within 60 days of the effective date of the Order (by January 7, 2009). The plan shall include, but not be limited to the following requirement:

1. Vegetation in the spring area should be removed to insure the integrity of the hypalon liner and to limit preferential pathways by which surface water may flow into the spring.

Additionally, EPA is requiring that within 30 days of the date of this letter, the System must verify the presence of a screen on the overflow pipe. If no screen exists, it must be installed within this timeframe.
