On March 19, 2008, representatives of the Administrator's Delegated Complainant and representatives of Respondent, including counsel of both parties, conducted a settlement conference in this matter at the offices of Region 5, in Chicago, Illinois. In addition, the parties, through counsel, have participated in several follow-up telephone conferences in an effort to resolve this matter. While no settlement has been finalized, the parties are continuing in their efforts to resolve this matter and are hopeful that this will be accomplished. There are issues that must be resolved regarding a proposed supplemental environmental project that is expected to be a component of a settlement.


