COMPLAINANT'S RESPONSE TO RESPONDENTS DUDLEY B. BURRELL AND  
THE DUDLEY B. BURRELL TRUST MOTION TO STRIKE THE COMPLAINANT'S  
PURPORTED INTERNET EVIDENCE OF RESPONDENTS' ADDRESS

Pursuant to Section 22.16 of the "Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/ Termination or Suspension of Permits" (Consolidated Rules), 40 C.F.R. § 22.16, Complainant, the Director of the Land and Chemicals Division, United States Environmental Protection Agency (EPA), Region 5, by and through his attorney, hereby responds to the Motion to Strike the Complainant's Purported Internet Evidence of Respondents' Address submitted on behalf of Respondents Dudley B. Burrell and the Dudley B. Burrell Trust. 40 C.F.R § 22.16 allows Complainant an opportunity to respond to this new motion.

Pursuant to 40 C.F.R. § 22.22, the Presiding Officer shall admit all evidence which is not irrelevant, immaterial, unduly repetitious, unreliable, or of little probative value, except evidence relating to settlement.

In their March 26, 2011, Motion to Strike Complainant's Purported Internet Evidence of Respondents' Address, Respondents argue that the web pages showing Dudley Burrell as a contact for leasing operations at 300 N. Indiana Avenue, Kankakee,

Illinois (the 300 North Indiana Avenue address) attached to Complainant's March 14, 2011, Memorandum in Opposition to Respondents Dudley B. Burrell and the Dudley B. Burrell Trust Motion to Quash Service of Process and Motion to Dismiss for Defective Service of Process should be stricken as inadmissible because they contain multiple layers of hearsay and are therefore untrustworthy, unreliable and incapable of being authenticated. They contest evidence that Respondents continued to use the 300 North Indiana Avenue address after 2003.

Complainant presented this evidence in response to the Respondents' request to quash service of the Complaint as to Dudley B. Burrell and the Dudley B. Burrell on the basis that Dudley Burrell's wife signed for it at the 300 North Indiana Avenue address.

The Complainant could reasonably expect that service to that address would achieve actual service of process on Respondents. Respondents have admitted that the 300 North Avenue Address was their address at the time of the 2003 inspection. *See* Respondents' Reply to Complainant's Response to Motion to Quash Service and Motion to Dismiss, at 2. As recently available listings advertising Respondents' leasing business and identifying Respondent Dudley B. Burrell as the person to contact at the 300 North Indiana Avenue address, the web pages show that Respondents continued to use that address after 2003 and that the public could expect to reach Dudley Burrell there.


As business advertisements, the web pages are not hearsay and are relevant. There is reliability in directories and addresses provided to solicit business. Moreover, even if the web pages were determined to be hearsay by the presiding officer, the web pages would still be admissible under the liberal standards for admissibility of evidence in 40 C.F.R. Part 22. They are not irrelevant, immaterial, unduly repetitions, unreliable,

or of little probative value. They show that the government could reasonably expect that service of Dudley Burrell at the 300 North Indiana address would achieve actual service.

A Memorandum in Opposition to Respondents Dudley B. Burrell and Dudley B. Burrell Trust Motion to Strike the Complainant's Purported Internet Evidence of Respondents' Address is also enclosed.

Respondents' motion should be denied, and a ruling in favor of Complainant should be granted.

MEMORANDUM IN OPPOSITION TO RESPONDENTS DUDLEY B. BURRELL  
AND THE DUDLEY B. BURRELL TRUST MOTION TO STRIKE THE  
COMPLAINANT'S PURPORTED INTERNET EVIDENCE OF RESPONDENTS'  
ADDRESS

Complainant, the Director of the Land and Chemicals Division, United States Environmental Protection Agency (EPA), Region 5, by and through his attorney, herewith submits this memorandum in opposition to Respondents' Motion to Strike the Complainant's Purported Internet Evidence of Respondents' Address.

Pursuant to 40 C.F.R. § 22.22, the Presiding Officer shall admit all evidence which is not irrelevant, immaterial, unduly repetitious, unreliable, or of little probative value, except evidence relating to settlement.

In their March 26, 2011, Motion to Strike Complainant's Purported Internet Evidence of Respondents' Address, Respondents argue that the web pages showing Dudley Burrell as a contact for leasing operations at 300 North Indiana Avenue, Kankakee, Illinois (the 300 North Indiana Avenue address) that Complainant included in its March 14, 2011, Memorandum in Opposition to Respondents Dudley B. Burrell and the Dudley B. Burrell Trust Motion to Quash Service of Process and Motion to Dismiss

for Defective Service of Process should be stricken as inadmissible because they contain multiple layers of hearsay and are thus untrustworthy, unreliable and incapable of being authenticated. Respondents contest evidence that Respondents continued to use the 300 North Indiana Avenue address after 2003, although they admit this was their address at the time of the May 28, 2003, inspection. *See* Respondent's Reply to Complainant's Response to Motion to Quash Service and Motion to Dismiss at 2.

Complainant presented this evidence in response to Respondents' arguments that the Complaint should be quashed as to Dudley B. Burrell and the Dudley B. Burrell Trust because it was signed for by Dudley Burrell's wife at the 300 North Indiana Avenue address in 2006.

In *In re C.W. Smith*, Docket No. CWA-04-2001-1501, 2002 EPA ALJ LEXIS 7 (ALJ, Order on Motions, February 6, 2002), Administrative Law Judge McGuire held that the Complainant could reasonably expect that service to that address would achieve actual service of process where the Complaint was sent by certified mail with return receipt requested and addressed to a mailing address that the Respondent had employed as a mailing address for legal documents. *C.W. Smith* followed the 10<sup>th</sup> Circuit's holding in *Katzon Brothers, Inc. v. United States Environmental Protection Agency*, that the rules of practice and the requirements of due process alone determine whether EPA's service of process is proper and that certified mail service under the Rules of Practice does not require actual delivery. *C.W. Smith*, EPA Docket No. CWA-04-2001-1501, 2002 EPA ALJ LEXIS 7, 19-20 (ALJ Order on Motions, February 6, 2002) (citing *Katzon Brothers, Inc. v. United States Environmental Protection Agency*, 839 F.2d 1396, 1399 (10th Cir. 1988)). It also followed the Regional Judicial Officer's holding in *In re Herman Roberts*,

Docket No. OPA 99-512, 2000 EPA RJO LEXIS 211 (RJO, "Order," April 14, 2000), that a person who signs a certified mail receipt green card and picks up mail at a respondent's business post office box is authorized to receive service of process under 40 C.F.R. Part 22. *C.W. Smith*, EPA Docket No. CWA-04-2001-1501, 2002 EPA ALJ LEXIS 7, 20 (ALJ Order on Motions, February 6, 2002).

Respondents attempt to distinguish *C.W. Smith* by pointing out that the complaint in that case was served on a lessee and assuming that the lessee was not "estranged," but *C.W. Smith* did not turn on whether parties were "estranged" and the administrative law judge did not accept a respondent's assertion that the lessee was not authorized to receive process on behalf of respondents.

Merely by moving into a new residence a defendant does not necessarily prevent his previous dwelling from being his "usual place of abode." *United Bank of Loves Park v. Dohm*, 450 N.E. 2d 974, 977 (Ill. App. 2d 1983). The underlying consideration is whether substituted service at the chosen dwelling place is reasonably likely to provide the defendant with actual notice of the proceedings. *Id.*

Service of the administrative complaint by certified mail with return receipt requested to the address most recently provided satisfies due process concerns. *See U.S. v. Serfling*, 1998 U.S. District LEXIS 3566 (N.D. Ill. 1998) (where the certified mail was unclaimed).<sup>1</sup>

<sup>1</sup> Under Fed. R. Civ. P. 4(e), service upon an individual may be effected: (1) pursuant to the law of the state in which the district court is located, or in which service is effected or (2) by delivering a copy of the summons and complaint to the individual personally or by leaving copies thereof at the individual's dwelling house or usual place of abode with some person of suitable age and discretion then residing therein or by delivering a copy to an agent authorized by appointment or by law to receive service of process.

The web pages include an Illinois directory listing and Section 8 rental housing listings advertising B&D Management Corporation (B&D) and Dudley Burrell Apartments at the 300 North Indiana Avenue address and identifying Dudley Burrell as the person to contact. According to Respondent Dudley B. Burrell, B&D was a closely held company owned and operated by him and his wife.<sup>2</sup> See March 1, 2011 Affidavit of Dudley B. Burrell at 3. The web pages were available on-line in March 2011, when they were printed. They show not only that this address for Respondents continued to be available to the general public long after 2003, but also that recent advertisements for Respondents' business list Dudley Burrell as a contact at this address. Indeed, apartment-rental8.com was created on December 5, 2009. See Attachment A. The 300 North Indiana Avenue address also shows up in the listings of the Dudley Burrell apartments on the government website, USAspending.gov, as recipients of Section 8 housing assistance payments program funding in years after 2003. See Attachment B.

There is reliability in directories and addresses given to solicit business. The web pages are commercial publications that the public rely on to find apartments. Potential tenants looking for apartments on the internet would expect to reach Dudley Burrell at the 300 North Indiana Avenue address. As business advertisements they are not hearsay and are relevant. Business advertisements have been found admissible in federal civil cases. See *In re Unumprovident Corp. Sec. Litig.*, 396 F. Supp. 2d 858, 876-77 (E.D. Tenn).

<sup>2</sup> Respondents attempt to draw an inference that most of the web pages were created prior to 2003 on the basis that they reference B&D and B&D dissolved on October 1, 2001; but the fact remains that the Burrells continued to use the B&D name after the dissolution of that corporation. The leases cited in the Complaint post date B&D's dissolution, yet used B&D letter head. See Complainant's Memorandum in Support of Motion for Default Order, Attachments 4-9 and 17. Respondent Dudley Burrell has even claimed that "[a]t all relevant times alleged in complainant's complaint, B&D was the company responsible for leasing apartment units owned by Burrell, wife, and their respective trusts." See March 1, 2011 Affidavit of Dudley B. Burrell, at 3. He cannot at the same time have us infer that the B&D name was not used after B&D's dissolution.



2005) (taking judicial notice of information publicly available to investors); *Woolsey v. Nat'l Transp. Safety Bd.*, 993 F.2d 516, 520 (5th Cir. 1993) (finding self-promoting articles and solicitation of business in press-kit and advertisements self-authenticating). Moreover, the evidence of internet registration has been found to be relevant. *See Retail Services, Inc. v. Freebies Publ'g*, 364 F.3d 535, 544-45 (4th Cir. 2004) (considering websites as evidence of the perspective of internet users seeking information); *Savin Corp. v. Savin Group*, 391 F.3d 535, 544-45 (2nd Cir. 2004) (determining similarity of trademarks).


Even if the web pages were determined to be hearsay, they would still be admissible under 40 C.F.R. Part 22, which contains liberal standards for admissibility of evidence. *See In re: William E. Comely, Inc. & Bleach Tek, Inc.*, 11 E.A.D. 247, 266 (EAB 2004) (citing *In re J.V. Peters & Co.*, 7 E.A.D. 77, 104 (EAB 1997) and *In re Great Lakes Div., Nat'l Steel Corp.*, 5 E.A.D. 355, 368-69 (EAB 1994) and rejecting Respondents' contention that sales figures are inadmissible as hearsay evidence); *In re Pyramid Chem. Co.*, 11 E.A. D. 657, 675 (EAB 2004). A presiding officer has broad discretion in determining what evidence is properly admissible and his ruling on such matters are entitled to substantial deference. *See J.V. Peters*, 7 E.A.D. at 99.

Hearsay is generally admissible in administrative proceedings to prove the truth of the matter asserted and for impeachment. *See In re Martex Farms, Inc.*, 2005 EPA ALJ LEXIS 51, 11 (ALJ 2005), *aff'd* 13 E.A.D. 464 (EAB 2008). Here, Respondents rely on Respondent Dudley Burrell's own attestations to claim that it is undisputed that he did not receive actual or constructive knowledge at the time the Complaint was received by his wife. They claim that the Complainant could not reasonably expect that

service of Respondents at the 300 North Indiana Avenue address would achieve actual service. The presiding adjudicator may rely on persuasive documentation over the statements of a party if the documentation possesses sufficient indicia of reliability and if the adjudicator, acting upon its fair judgment of the situation, finds the documentation to be more reliable than the party's statements. *Pyramid*, 11 E.A.D. at 666 n.16 (citing *Great Lakes Div. of Nat'l Steel*, 5 E.A.D. at 369-73).

Since the websites evidence that Dudley Burrell continued to be a contact for the leasing operations at the 300 Indiana North Avenue address, they provide evidence that Respondents continued to use the 300 North Indiana Avenue address. They are relevant and probative to the issue of whether the government could reasonably expect that service of Dudley Burrell at the 300 North Indiana address would achieve actual service. As a recent advertisement for the B&D leasing business, they are not irrelevant, immaterial, unduly repetitious, unreliable, or of little probative value.

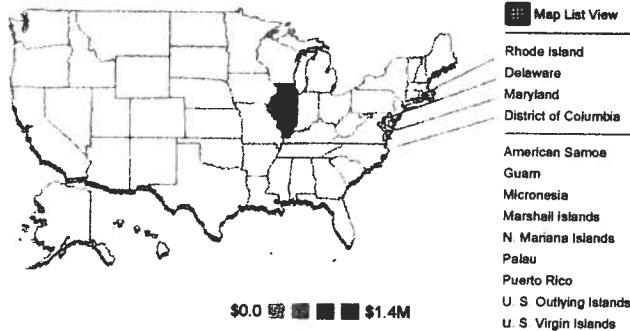
