Dear Mr. Son:

Enclosed is a Proposed Administrative Order (Order) issued to Robinowitz Oil for violation of the Safe Drinking Water Act (SDWA). Violations were identified based on our review of files that we maintain on the referenced well. The violations were for failure to plug the Alred 1 well within one year after termination of injection operations and maintaining the well in a manner which could allow movement of fluids into underground sources of drinking water. The enclosed Order does not assess a monetary penalty; however, it does require compliance with SDWA requirements. You would be required to plug the well in compliance with Environmental Protection Agency (EPA) regulations.

You have the right to request a hearing regarding the violations alleged in the Order. Please refer to the enclosed Part 22, "Consolidated Rules of Practice," for information regarding hearing and settlement procedures. Also, note that should you fail to request a hearing within thirty (30) days of your receipt of this Order, you will waive your right to such a hearing, and may be subject to the compliance terms without further proceedings. Whether or not you request a hearing, we invite you to confer with us informally. If you choose not to request a hearing, we will review any comments on the proposed Order received from you and the public and determine whether the Order will become final.

Also enclosed is an "Information Sheet" relating to the Small Business Regulatory Enforcement Fairness Act and a "Notice of Registrant's Duty to Disclose" relating to the disclosure of environmental legal proceedings to the Securities and Exchange Commission.


The EPA is committed to ensuring compliance with the requirements of the Underground Injection Control program and my staff will assist you in any way possible.

STATUTORY AUTHORITY

The following findings are made and Order issued under the authority vested in the Administrator of the U.S. Environmental Protection Agency ("EPA") by Section 1423(c) of the Safe Drinking Water Act ("Act"), 42 U.S.C. § 300h-2(c). The authority to issue this Order has been delegated by the Administrator to the Regional Administrator of EPA Region 6 who delegated such authority to the Director of the Compliance Assurance and Enforcement Division. The EPA has primary enforcement responsibility for underground injection within the meaning of Section 1422(c) of the Act, 42 U.S.C. § 300h-1(c), to ensure that owners or operators of Class II injection wells within Osage County, Oklahoma, comply with the requirements of the Act.

FINDINGS

1. Respondent, Robinowitz Oil, is a "person," within the meaning of Section 1401(12) of the Act, 42 U.S.C. § 300f(12).

2. At all times relevant to the violation alleged herein, Respondent operated an injection well located in the Northeast Quarter of Section 36, Township 25 North, Range 7 East, Atlantic Field, Osage County, Oklahoma, designated as Well Number Alred 1 and EPA Inventory Number OS0902 ("the well").

3. Respondent is subject to underground injection control ("UIC") program requirements set forth at 40 C.F.R. Part 147, Subpart GGG, which are authorized under Section 1421 of the Act, 42 U.S.C. § 300h.

4. EPA regulations require the operator of an "injection well," as defined at 40 C.F.R. § 147.2902, to plug the well within one year after termination of injection operations, pursuant to 40 C.F.R. § 147.2905.

5. Respondent violated the regulations cited above by failing to plug the well within one year after termination of injection operations.

6. Therefore, Respondent violated the regulations set forth at 40 C.F.R. § 147.2905.

7. EPA regulations require the operator of an injection well to maintain its wells in a manner that would prevent contaminants from moving through the well bore into underground sources of drinking water ("USDWs"), pursuant to 40 C.F.R. § 147.2903(b).

8. Respondent violated the regulations cited above by maintaining the well with a static fluid level in the well annulus above the base of USDWs.

9. Therefore, Respondent violated regulations set forth at 40 C.F.R. § 147.2903(b).

10. Based on the foregoing findings and under the authority of Section 1423(c) of the Act, it is hereby ordered that Respondent shall plug the well according to 40 C.F.R. § 147.2905 within thirty (30) days after the effective date of the Final AO.

NOTICE OF OPPORTUNITY TO REQUEST A HEARING

11. Respondent may request a hearing to contest the issuance of this Order, pursuant to Section 1423(c)(3)(A) of the Act, 42 U.S.C. § 300h-2(c)(3)(A). Submit the hearing request to the Regional Hearing Clerk (6RC-D); U.S. EPA Region 6; 1445 Ross Avenue, Suite 1200; Dallas, TX 75202 within thirty (30) days of the date of receipt of this Proposed Administrative Order.

12. A request for hearing should be included in any response to this Order. Respondent must file a response in order to preserve the right to a hearing or to pursue other relief.

13. Should a hearing be requested, members of the public who commented on the issuance of this Order during the public comment period would have a right to be heard and present evidence at a hearing under Section 1423(c)(3)(C) of the Act, 42 U.S.C. § 300h-2(c)(3)(C).

GENERAL PROVISIONS

14. This Order does not constitute a waiver, suspension, or modification of the requirements of 40 C.F.R. Part 147, Subpart GGG, which remain in full force and effect.

15. Issuance of this Order is not an election by EPA to forego any civil or criminal action otherwise authorized under the Act.

16. Violation of the terms of this Order after its effective date or date of final judgment as described in Section 1423(c)(6) of the Act, 42 U.S.C. § 300h-2(c)(6), may subject Respondent to further enforcement action, including a civil action for enforcement of this Order under Section 1423(b) of the Act, 42 U.S.C. § 300h-2(b), and civil and criminal penalties for violations of the compliance terms of this Order under Section 1423(b)(1) and (2) of the Act, 42 U.S.C. § 300h-2(b)(1) and (2).

SETTLEMENT

17. EPA encourages all parties against whom an administrative order is proposed, to pursue the possibility of settlement through informal meetings with EPA. Regardless of whether a formal hearing is requested, Respondent may confer informally with EPA about the alleged violations. Respondent may wish to appear at any informal conference or formal hearing personally, by counsel or other

representative, or both. To request an informal conference on the matters described in this Order, please contact Mr. Ronald Van Wyk, of my staff, at (214) 665-6459.

18. If this action is settled without a formal hearing, it will be concluded by issuance of a Final Order.

EFFECTIVE DATE

19. This Order becomes effective thirty (30) days after issuance unless an appeal is taken pursuant to Section 1423(c)(6) of the Act, 42 U.S.C. § 300h-2(c)(6).

The Respondent in this action may request a public hearing. If the Respondent requests a hearing, those persons who have commented during the comment period will be notified of the hearing and may appear at the hearing to present evidence on the appropriateness of the proposed order and penalty assessment. The final AO will be issued after the close of the comment period unless a public hearing is requested by the Respondent. The final order will be effective 30 days after issuance unless a person who commented on the proposed order appeals the final order.
