Complainant United States Environmental Protection Agency, Region 8 (EPA) and the City of Eagle Butte, South Dakota (Respondent) hereby consent and agree as follows:

- 1. On September 30, 2010, the EPA issued an Administrative Complaint and Notice of Opportunity for Hearing (complaint) alleging that the Respondent violated the terms of a Clean Water Act National Pollutant Discharge Elimination System permit. The complaint proposed that the Respondent pay an administrative civil penalty for those violations, pursuant to § 309(g) of the Act, 33 U.S.C. § 1319(g).
- The Respondent admits the jurisdictional allegations of the complaint and neither admits nor denies the specific factual allegations of the complaint.
- 3. The Respondent waives its right to a hearing before any tribunal to contest any issue of law or fact set forth in the complaint or in this consent agreement.
  - 4. This consent agreement, upon incorporation into a final order, applies to and is

binding upon EPA and upon the Respondent. Any change in the ownership or operation of the site at issue, including, but not limited to, any transfer of assets or real or personal property, shall not alter the Respondent's responsibilities under this agreement. This consent agreement contains all terms of the settlement agreed to by the parties.

- 5. The Respondent consents and agrees to pay a civil penalty in the amount of two thousand five hundred dollars (\$2,500.00) in the manner described below:
  - a. Payment shall be made in a single installment due no later than thirty calendar days from the date of the final order, issued by the Regional Judicial Officer, that adopts this consent agreement. If the due date for the payment falls on a weekend or legal federal holiday, then the due date is the next business day. The date payment is made is considered to be the date processed by U.S. Bank, described below. Payment must be received by 11:00 AM Eastern Standard Time to be considered received that day.
  - b. Payment shall be made by remitting a cashier's or certified check, or making a wire transfer or on-line payment, including the name and docket number of this case, for the amount stated in part "a," above, payable to "Treasurer, United States of America," as follows:

- c. In the event payment is not received by the specified due date, interest accrues from the date of the final order, not the due date, at a rate established by the Secretary of the Treasury pursuant to 31 U.S.C. § 3717, and will continue to accrue until payment in full is received (i.e., on the 1<sup>st</sup> late day, 30 days of interest will have accrued).
- d. In addition, a handling charge of fifteen dollars (\$15) shall be assessed the 31<sup>st</sup> day from the due date of any payment, and for each subsequent thirty day period that the debt, or any portion thereof, remains unpaid. In addition, a six percent (6%) per annum penalty shall be assessed on any unpaid principal amount if payment is not received within 30 days of the due date. Payments are first applied to outstanding handling charges, 6% penalty interest, and late interest. The remainder is then applied to the outstanding principal amount.

- e. EPA has agreed to accept a penalty of \$2,500 because the Respondent has provided evidence that it is unable to pay the penalty proposed in the complaint.
- The Respondent attests that it has supplied EPA with all information in the Respondent's possession that is required by the Findings of Violation and Order for Compliance issued by the EPA on September 30, 2010 (Docket No. CWA-08-2010-0040).
- Nothing in this consent agreement shall relieve the Respondent of the duty to comply with the Act and its implementing regulations.
- 8. Any failure by the Respondent to comply with any of the terms of this consent agreement shall constitute a breach of the consent agreement and may result in referral of the matter to the Department of Justice for enforcement of this consent agreement and for such other relief as may be appropriate.
- 9. Nothing in this consent agreement shall be construed as a waiver by the EPA or any other federal entity of its authority to seek costs or any appropriate penalty associated with any collection action instituted as a result of the Respondent's failure to perform pursuant to the terms of this consent agreement.
- 10. The individual signing this consent agreement on behalf of the Respondent certifies that he/she is fully authorized to enter into this consent agreement and to bind the relevant Respondent to the terms and conditions of this consent agreement.
- The parties agree to submit this consent agreement to the Regional Judicial
   Officer, with a request that it be incorporated into a final order.

- 12. Each party shall bear its own costs and attorney fees in this matter.
- 13. This consent agreement, upon incorporation into a final order by the Regional Judicial Officer and full satisfaction by the parties, shall be a complete and full civil settlement of the United States' claims for civil penalties for the specific violations alleged in the complaint.
