Dear Mr. Briggs:

This letter is an addendum to the Administrative Order (Order) issued on September 5, 2014, to the Western Cooperative Company (Company) as owner and/or operator of the Frontier Mart public water system (System). The purpose of this letter is to approve the schedule submitted on October 30, 2014, and revised on January 9, 2015, by Mr. Scott Feller, Petroleum Division Manager of the Western Cooperative Company, on behalf of the Company, for coming into consistent compliance with the nitrate maximum contaminant level (MCL). The schedule is hereby incorporated into the Order per paragraph 13 (page 2) of the Order.

Action	Completion Date
Submit permit request to Wyoming DEQ for proposed installation of a reverse osmosis (RO) system at Frontier Mart public water system.	Completed December 24, 2014.
Wyoming DEQ approval of proposed RO system installation project.	Completed January 15, 2015.
Install polyethylene tubing to all potable water use points through the facility.	April 16, 2015.
Install RO system to treat all potable water at the facility (including for icemakers, all sinks and lavatories, and water supplied to coffee makers and fountain soda dispensers).	April 16, 2015.

Pursuant to paragraph 16 of the Order, the System shall achieve compliance with the total coliform MCL by the final compliance deadline in this approved schedule, April 16, 2015. The EPA is authorized to seek penalties if these deadlines are not met. If the Company has a reasonable basis to believe it may be unable to meet any deadline in the schedule, it shall notify the EPA well in advance of the scheduled deadline to request an extension. The EPA may, in its discretion, consider granting an extension.
