Dear Mr. Jorgenson:

This addendum to the Administrative Order issued January 23, 2007, to Lake Powell Management, owner of the Lake Powell Management water system (the System), incorporates the updated schedule for monitoring and reporting for the System. As stated in the April 17, 2007 letter (e-mail) from Steve Jorgenson on behalf of Lake Powell Management, in mid-December 2006, during a routine monitoring event, it was discovered that the well was no longer pumping water. After several attempts to fix the problem, the public water system is currently in the process of having the pump pulled from the well and replaced. This task requires the use of a crane which is scheduled for April 25, 2007. Additionally, Steve Jorgenson has informed EPA that Lake Powell Management consists of year round boat storage and a seasonal convenience store which is open annually from late May – early October. The system does not serve water to the public from November to April. As a result of these events, the public water system is currently unable to comply with the monitoring requirements of the Order. Therefore, this letter constitutes the written approval by EPA of Lake Powell Management's request to extend the timeline for monitoring of nitrate, total coliform, and issuance of the public notice. The System has been advised to contact the State and have their open season changed to reflect a seasonal operation. The System will be required to monitor quarterly for total coliform until EPA receives notice from the State that they approve the seasonal status of the System.

The following schedule lists the action to be taken, deadline date and completion date if applicable.

Monitor the System's water for nitrate.	June 7, 2007	
Issue public notice of violations included in the Order.	Within 30 days of commencing public operations at the System in 2007.
