amine 4 2,4-D, 8-ounce container permectrin II

Based upon inspection activities and/or tests there is reason to believe that the pesticide(s) and/or device(s) is/are in violation of the provision(s) of Section 12 of FIFRA. Specifically, the violation(s) concern: misbranded (missing part of the label)

This order shall pertain to all quantities of the above named pesticides or devices within the ownership, control, or custody of the above named person, wherever located. These pesticides and/or devices shall not be sold, used, or removed from the premises for any reason without prior written approval from EPA. This Order shall be **EFFECTIVE IMMEDIATELY** upon receipt by Respondent.

Any person violating the terms or provisions of this order shall be subject to the penalties prescribed in Section 14 of FIFRA.
