ORDER GRANTING MOTION  
TO EXTEND TIME TO RESPOND TO COMPLAINT

By motion filed October 13, 2011, the Complainant seeks a 60-day extension of time to file an answer to the above-entitled administrative complaint to January 10, 2012. On September 30, 2011, the Complainant filed the above-entitled action against Respondent Leading Edge Aviation Services, Inc. which alleges violations of Rule 1118 of the Mojave Desert Air Quality Management District as incorporated in the State Implementation Plan for California pursuant to Section 110 of the Clean Air Act, 42 U.S.C. § 7410. Respondent was served with the Complaint on or about October 12, 2011.

Section 22.7(b) of the Consolidated Rules of Practice, 40 C.F.R. § 22.7(b), provides that a motion for extension of time may be granted "for good cause shown, and after consideration of prejudice to other parties."

On the basis of the Complainant's motion, including the Complainant's representation that the parties are involved in settlement discussions and that the Respondent does not oppose this motion, it appears that there is good cause for an extension of time, and there will be no prejudice to either party from granting the requested extension.

IT IS THEREFORE ORDERED THAT:

The time for Respondent to answer the Complaint and request a hearing is extended to January 10, 2012.
