Dear Judge Buschmann:

This first status report is being provided pursuant to the February 23, 2012 email request of your Legal Staff Assistant Knolyn Jones. On June 3, 2011, the U.S. Environmental Protection Agency, Region 2 ("Complainant") filed a Complaint, Compliance Order and Notice of Opportunity for Hearing ("Complaint") in the above-referenced matter. Respondents filed a joint Answer to the Complaint on July 12, 2011. Complainant subsequently submitted a Motion for Change in Name of Corporate Respondent on December 8, 2011. The Motion was granted by Judge Barbara A. Gunning on December 21, 2011. The Order on Motion for Change in Name of Corporate Respondent stated that although the change requested is ministerial, the filing of amended complaint is needed. Complainant has drafted an Amended Complaint which will be circulated for concurrence and is expected to be served and filed with the Regional Hearing Clerk by the middle of March. Respondents shall have twenty days from the date of service to file an amended answer, if they choose to do so.

Pursuant to the October 19, 2011 Prehearing Order of Judge Gunning, the parties have completed their prehearing exchange of information. Respondents claimed in their Prehearing Exchange that the Paperwork Reduction Act ("PRA"), 44 U.S.C. §§ 3501 – 3521 applies to this case, and Complainant is thereby barred from imposing any penalty against Respondents. On February 7, 2012, Judge Gunning issued an Order on the Applicability of the Paperwork Reduction Act rejecting Respondents' arguments and holding that the PRA does not present a valid defense for Respondents.

Complainant and Respondents have discussed compliance and penalty issues in their efforts to explore a settlement of this case. Counsel for Complainant expects to speak with Respondents' counsel later this week to discuss Respondents' progress on compliance and Complainant's proposal for a settlement of the proposed penalty.
