ORDER TO SHOW CAUSE

By Order dated March 28, 2008, Complainant was required to file its prehearing exchange on or before May 16, 2008. However, to date, the Complainant has failed to do so.¹ Section 22.17 (a) of the Consolidated Rules of Practice Governing The Administrative Assessment of Penalties provides that a party may be found in default for failing to comply with a Prehearing Order.

Therefore, Complainant is Ordered to show good cause on or before **June 15, 2008** why it failed to submit its prehearing exchange as required by the Prehearing Order and why a Default should not be entered against it.

¹ On April 28, 2008, Complainant submitted a "Settlement Status Report" which indicated that on April 25, 2008 the parties had reached a settlement in principle and requested that the "settlement filing deadline of May 16, 2008 be extended by two weeks until May 30, 2008, to allow sufficient time to obtain cost estimates and other information underlying the SEP." Despite being made in an untimely filed Status Report and in improper form (*i.e.* not in a Motion), this request was granted by Order dated April 29, 2008. The Settlement Status Report did not request any extension of time for filing of the Complainant's Prehearing Exchange and none has been granted. To date, obviously, no Consent Agreement has not been filed either.
