**ORDER GRANTING UNOPPOSED MOTION FOR EXTENSION OF TIME
TO FILE ANSWER**

This action, initiated by the Complainant, the Director of the Compliance Assurance and Enforcement Division, Environmental Protection Agency, Region 6, seeks to assess a Class I administrative penalty under Section 309(g) of the Clean Water Act ("CWA"), 33 U.S.C. § 1319(g). Class I penalty actions are governed by the procedures set forth in 40 C.F.R. Part 22, Subpart I, Administrative Proceedings Not Governed by Section 554 of the Administrative Procedure Act. I have been assigned to act as Presiding Officer in this case.

Complainant filed the Administrative Complaint ("Complaint") in this matter on January 20, 2011. On February 18, 2011, the Complainant filed an Unopposed Motion for Extension of Time to File an Answer ("Motion") seeking to extend the due date for Respondent's answer for 20 days. Under the circumstances, I find good cause to grant Respondent's motion for an extension of time.

THEREFORE, the deadline for Respondent to file its answer and request for a hearing in this matter is extended until **March 21, 2011**. If a consent agreement and final order resolving this case has not been filed by March 21, 2011, Respondent may seek a further extension of this deadline only by filing a timely motion showing good cause for why such extension should be granted. Failure to file an answer or to obtain a further extension of time on or before March 21, 2011, may result in Respondent being found in default pursuant to 40 C.F.R. § 22.17.


