West Virginia Division of Natural Resources, Docket No. CWA-03-2025-0019DN**

Dear Mr. Williams:

On December 17, 2024, the United States Environmental Protection Agency Region 3 ("EPA") and the West Virginia Division of Natural Resources ("Respondent") entered into an Administrative Order on Consent, Docket No. CWA-03-2025-0019DN ("the Order"). The Order required that the Respondent implement certain injunctive relief for compliance and provide documentation of these activities to the EPA.

Based on the EPA's review, it is the EPA's belief that Respondent has complied with all actions required by the Order, and the EPA is therefore terminating the Order. In accordance with Section VII of the Order, this letter serves as written notification of termination of the Order.

Please note that you must continue to comply with any applicable Clean Water Act ("CWA") requirements and any applicable National Pollutant Discharge Elimination System ("NPDES") permit(s). Any noncompliance with the CWA or a current or future NPDES permit could result in the initiation of an additional enforcement action pursuant to the federal enforcement provisions set forth in Section 309 of the CWA, 33 U.S.C. § 1319. You are therefore encouraged to pay close attention to all permit conditions and to maintain any plans or standard operating procedures to ensure compliance.
