MOTION FOR EXTENSION OF TIME

By Order dated September 14, 2017, your Honor granted Complainant's Motion for Default Judgment on Liability and ordered the Complainant to file and serve, on or before October 30, 2017, the Motion for Penalty, together with supporting documentation which will provide factual grounds for the proposed penalty against the above-captioned Respondent, in accordance with 40 C.F.R. §§ 22.5 and 22.16.

Complainant hereby moves, pursuant to 40 C.F.R. § 22.16(a), for a six month (one-hundred and eighty (180) days) extension of time, from October 30, 2017 until April 30, 2018, to file the Motion for Penalty, for the following reasons:

(1) On or about September 7, 2017 and September 20, 2017, Hurricanes Irma and Maria, respectively, caused unprecedented island-wide damage to the Commonwealth of Puerto Rico. Such damage includes destroyed homes, flooded communities, impassable roads, and damaged infrastructure, leaving residents without electricity, water and communications. Normal business operations have been put on hold indefinitely. Accordingly, it would be insensitive as well as impractical for EPA to attempt to serve the Respondent with motion papers at this time. As such, a temporary moratorium on legal issues in this matter is warranted.

(2) Once communications with Puerto Rico have been re-established and normal business operations

resume, EPA would like additional time to attempt to reach the Respondent and to see if renewed

settlement negotiations might be possible prior to filing a default Motion for Penalty.

Based on the aforementioned, Complainant's counsel asserts that good cause exists for granting this

motion for an extension of six months, or one-hundred and eighty (180) days, until April 30, 2018, to

file the appropriate dispositive default Motion for Penalty. As the request is made to allow the

Respondent a meaningful opportunity to respond to any such motion and to participate in this action, a

grant of this extension request will not prejudice any of the parties.
