Motion Requesting Extension of Time to File CA/FO

COMES NOW Complainant, the U.S. Environmental Protection Agency ("EPA" or "Complainant") through the undersigned attorney, and respectfully alleges, prays and requests as follows:

1. On May 12, 2011, Complainant requested a second extension of ten (10) additional days to file the CA/FO, which was also granted by this Honorable Court. Complainant stated that, to the best of our knowledge, no further extension would be necessary, since we expected to be able to file the fully executed CA/FO within the period of time requested. However, in spite of our efforts, the procedure has not been concluded due to the extensive process of concurrence, which involves the signature of several persons both in Puerto Rico and New York.

2. Complainant recognizes that it is in the best interest of all the parties involved to file the CA/FO as soon as possible. Therefore, all efforts are being made in order to expedite the concurrence process of the remaining officials.
3. Since the process of concurrence and signature to file a fully executed CA/FO has not been completed, Complainant respectfully requests a final extension of ten (10) additional days to submit the fully executed CA/FO.
