INTRODUCTION (JURISDICTION)

- 1. This civil administrative enforcement action is authorized by Congress in section 14(a) of the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA). 7 U.S.C. section 136l(a). The rules for this proceeding are the "Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties, Issuance of Compliance or Corrective Action Orders and the Revocation, Termination or Suspension of Permits ("Rules of Practice")," 40 C.F.R. part 22, a copy of which is enclosed.
- 2. The undersigned EPA officials have been properly delegated the authority to issue this action.
- 3. EPA alleges that Respondent has violated FIFRA, by failing to submit an annual pesticide production report, as more fully explained below. FIFRA authorizes the assessment of a civil penalty for violations of the Act. 7 U.S.C. section 136*l*(a).

NOTICE OF OPPORTUNITY FOR A HEARING

- 4. Respondent has the right to a public hearing before an administrative law judge (ALJ) to disagree with (1) any fact stated (alleged) by EPA in the complaint, or (2) the appropriateness of the proposed penalty.
- 5. To disagree with the complaint and assert your right to a hearing, Respondent must file a written answer (and one copy) with the Regional Hearing Clerk (1595 Wynkoop Street, Denver, Colorado 80202) within 30 days of receiving this complaint. The answer must clearly admit, deny or explain the factual allegations of the complaint, the grounds for any defense, the facts you may dispute, and your specific request for a public hearing. Please see section

22.15 of the Rules of Practice for a complete description of what must be in your answer. FAILURE TO FILE AN ANSWER AND REQUEST FOR HEARING WITHIN 30 DAYS MAY WAIVE RESPONDENT'S RIGHT TO DISAGREE WITH THE ALLEGATIONS OR PROPOSED PENALTY, AND RESULT IN A DEFAULT JUDGMENT AND ASSESSMENT OF THE PENALTY PROPOSED IN THE COMPLAINT.

QUICK RESOLUTION

6. Respondent may resolve this proceeding at any time by paying the specific penalty (\$1,500) proposed in the complaint. Such payment need not contain any response to, or admission of, the allegations in the complaint. Such payment constitutes a waiver of respondent's right to contest the allegations and to appeal the final order. See section 22.18 of the Rules of Practice for a full explanation of the quick resolution process. This payment shall be made by remitting a cashier's or certified check for that amount, payable to "Treasurer, United States of America," to:

ALLEGATIONS

The following general allegations apply to each count of this complaint:

8. EPA has jurisdiction over this matter pursuant to section 14(a)(1) of FIFRA, 7 U.S.C. section 136l(a)(1).

- 9. Respondent, Pipestone Products Co., is a "person" within the meaning of section 2(s) of FIFRA, 7 U.S.C. section 136(s), and is therefore subject to regulation.
- 10. Respondent operates a pesticide producing establishment ("the Establishment") at 303 West 31st. Street, Yankton, South Dakota.
- 11. Respondent is incorporated in the State of Minnesota.
- Respondent is a registered pesticide producer as defined by section 2(w) of FIFRA.
- 13. FIFRA section 7(c)(1), 7 U.S.C. section 136e(c)(1), requires all registered pesticide producers to file an annual report "...of the types and amounts of pesticides and, if applicable, active ingredients used in producing pesticides...." Further, regulations promulgated pursuant to FIFRA section 7 require such annual report to be filed on or before March 1 for the preceding calendar year. 40 C.F.R. section 167.85(d).
- 14. FIFRA section 12(a)(2)(L), 7 U.S.C. section 136j(a)(2)(L), provides, "it shall be unlawful for any person-- who is a producer to violate any of the provisions of section 136e [FIFRA section 7] of this title."
- Respondent indicated in its 2006 pesticide production report that it would produce pesticides in 2007.
- Respondent failed to file a 2007 annual pesticide production report for the pesticides produced at its Establishment by Respondent or any of its predecessor entities.
- 17. The Respondent, therefore, having failed to file an annual pesticide production report for 2007 on or before March 1, 2008, has violated section 12(a)(2)(L) of FIFRA, 7 U.S.C. section 136j(a)(2)(L).

PROPOSED CIVIL PENALTY

FIFRA authorizes the assessment of a civil penalty of up to \$6,500 for each offense of the Act. FIFRA requires EPA to consider the appropriateness of the penalty to the size of the business, the effect on the person's ability to continue in business, and the gravity of the violation. EPA has established Agency policies that provide a rational and consistent method for applying statutory factors to the

circumstances of specific cases. A narrative description of the reasoning behind the penalty proposed in this case is attached to this complaint (Complainant's Exhibit 1), along with copies of the EPA policies. For the FIFRA violation alleged in this complaint, EPA proposes a penalty of \$1,500.

Penalty Calculation Narrative:

- 1. To ensure a uniform and consistent enforcement response and application of the statutory penalty criteria in the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), the U.S. Environmental Protection Agency (EPA) developed the June 2007 Enforcement Response Policy for Pesticide Producing Establishment Reporting Requirement (2007 Policy).
- 2. According to the 2007 Policy, the appropriate enforcement response for failing to file EPA Form 3540-16, the annual pesticide production report for a second time violator is a civil penalty.
- 3. FIFRA Section 14(a)(4) requires EPA to "consider the appropriateness of the penalty to the size of the business of the person charged, the effect of the penalty on the person's ability to continue in business, and the gravity of the violation when calculating the civil penalty amount."
- 4. Following the guidance in the 2007 Policy, EPA calculates a proposed civil penalty using the following process. First, the gravity of the offense is identified Table 1 in the 2007 Policy. Table 1 identifies a violation of FIFRA section 12(a)(2)(L) to be 'Non Reporting.'
- 5. Second, according to the 2007 policy, the respondent's compliance history is evaluated. Table 1 identifies Pipestone Products Co. to be a second time violator. Pipestone Products Inc. was issued a NOW for submitting a late report for the 2006 reporting year.
- 6. Third, according to the 2007 policy, the size of business is taken into account. The size of business is determined from the company's gross revenues from all revenue sources during the prior calendar year. Pipestone Products Co. is determined to be Category III having annual gross sales revenues of 10 million or less.
- 7. Fourth, according to the 2007 policy adjustment for specific penalty factors are taken into account. The following factors are particularly relevant to adjusting the penalty for violations of FIFRA 7(c) reporting requirements for: (1) the violator's ability to continue in business (ability to pay) and (2) good faith efforts to comply with FIFRA. No penalty adjustments are made at this time.
- 8. In sum, EPA arrived at a total penalty of \$1,500 for Pipestone Products Co.'s violations of FIFRA sections 12(a)(2)(L) by considering all of the FIFRA Section 14(a)(4) penalty criteria through the use of the 2007 Policy.
