Dear Evergreen Properties and Ms. Auch:

On June 30, 2014, the U.S. Environmental Protection Agency issued an Administrative Order (Order) ordering Evergreen Properties LLC (LLC) and Randall Spencer, as owner and/or operator of the Evergreen Properties Public Water System (System), to comply with the Safe Drinking Water Act (SDWA), 42 U.S.C. Section 300f *et seq.*, and its implementing regulations, the National Primary Drinking Water Regulations (NPDWRs), 40 C.F.R. part 141. Mr. Spencer has been replaced as operator of the System by Ms. Auch.

Our records indicate that the LLC is, again, in violation of the Order. Among other things, the Order included the following requirements (from paragraphs 10 and 12 on page 2 of the Order) in which the LLC and Mr. Spencer are named as Respondents:

1. Respondents shall monitor the System's water for nitrate within 30 days after the date of this Order and quarterly thereafter until notified by the EPA in writing of a different monitoring schedule. 40 C.F.R. § 141.23(d).

The EPA has not received a 2nd quarter (April-June) 2015 nitrate monitoring result. We have nitrate results for March and September 2015.

2. Respondents shall report any violation of the Drinking Water Regulations to the EPA within 48 hours of the violation occurring, as required by 40 C.F.R. § 141.31(b).

Respondent did not report the nitrate monitoring violation cited above to the EPA.

The EPA is considering additional enforcement action as a result of the LLC's non-compliance with the Order. Violating an administrative order may lead to (1) a penalty of up to \$37,500 per day per violation of the Order, and/or (2) a court injunction ordering compliance.
