ORDER TO SUPPLEMENT THE RECORD


On April 2, 2013, Complainant, Director of the Air, Pesticides, and Toxics Management Division of the United States Environmental Protection Agency Region 4, filed a Motion for Default (“Motion”) against Respondent, John Rice, LLC. Complainant seeks issuance of a default order against Respondent, pursuant to 40 C.F.R. §§ 22.17 based upon Respondent’s alleged failure to timely respond to the Complaint filed on May 25, 2012 and served upon Respondent on May 29, 2012. Among other exhibits filed in support of the above-referenced Complaint, Complainant’s Motion refers to Exhibit A as the attached Complaint and Exhibit B as the “Amended Proof of Service of Complaint, with attachment.” While there is an Exhibit A containing a copy of the Complaint, there is a second Exhibit labeled “A” which appears to be a UPS Delivery Notification. Exhibit B, which does not have an attachment, is a “Proof of Delivery” for an item with the same tracking number as that on the UPS Delivery Notification.

IT IS ORDERED:

On or before **July 19, 2013**, Counsel for Complainant is to submit in writing with a copy to Respondent:

1. Clarification of the Exhibits attached to the Complaint; and
2. Explanation of the reference to the Proof of Service as “Amended.” If there is a Proof of Service for a prior attempted service upon Respondent, Counsel is to provide a copy of that Proof of Service as well.
