AND CONSENT AGREEMENT**


On January 30, 2012, the parties filed a second Joint Motion to Amend Administrative Complaint and Consent Agreement. The Motion requests revisions to Appendix A, Tables A-2 through A-4 to reflect accurate future emission sources in these tables.

On November 3, 2011, the Parties filed a Joint Motion to Amend Administrative Complaint and Consent Agreement. The Motion requests, pursuant to paragraphs D.1.a and F.13 of the Agreement, that the Complaint and Consent Agreement be amended to include a Revised Appendix A and modification of the penalty.

The second Joint Motion does not alter the total number of emission sources listed in Appendix A nor does it alter the revisions requested and approved in the November 3, 2011, Order. Pursuant to paragraph F.12 of the Agreement, the parties agree to amend and modify tables A-2 through A-4 of Appendix A, and the court approves the modifications as stated in the second Joint Motion.

The Respondent is hereby **ORDERED** to comply with all of the terms of the Consent Agreement, which was effective on August 29, 2011 by Final Order.
