Expedited Settlement Agreement and Final Order  
Pursuant to Clean Water Act Section 309(g)(2)(A)

NPDES Permit No. MS0044075

The undersigned representative of the United States Environmental Protection Agency (EPA) and the Town of French Camp, Mississippi (Respondent) enter into this Expedited Settlement Agreement (ESA or Agreement) to resolve Respondent's civil penalty liability for alleged violations of the National Pollutant Discharge Elimination System permit cited above (Permit).

On June 2, 2022, representatives of the EPA inspected Respondent's facility at Highway 413 and Old Natchez Trace, French Camp, Mississippi (Site). The EPA finds that: (1) Respondent, who is the owner and operator of the Site, failed to comply with the Permit issued pursuant to Section 402 of the Clean Water Act (Act), 33 U.S.C. § 1342, in violation of Section 301 of the Act, 33 U.S.C. § 1311; (2) Respondent is a "person" as defined in Section 502(5) of the Act, 33 U.S.C. § 1362(5); and (3) Respondent is responsible for the alleged violations specified in the attached "Expedited Settlement Offer Findings and Alleged Violations Form" (Alleged Violations Form). The Alleged Violations Form is hereby incorporated into this Agreement by reference.

Respondent admits that EPA has jurisdiction over the subject matter alleged in this ESA and neither admits nor denies the factual allegations alleged in the Alleged Violations Form.

The EPA is authorized to enter into this Agreement under the authority vested in the Administrator by Section 309(g) of the Act, 33 U.S.C. § 1319(g), and by 40 C.F.R. §§ 22.13(b) and 22.18.

Respondent consents to the assessment of a civil penalty and agrees to pay \$580. Respondent waives the right to: (1) contest the allegations in the Alleged Violations Form; (2) a hearing pursuant to Section 309(g)(2) of the Act, 33 U.S.C. § 1319(g)(2); (3) appeal the Final Order; and (4) judicial

review pursuant to Section 309(g)(8) of the Act, 33 U.S.C. § 1319(g)(8). The civil penalty will be due within thirty (30) days of the Effective Date of this Expedited Settlement Agreement and Final Order and shall be made in accordance with the attached Expedited Settlement Agreement Payment Instructions (Payment Instructions), incorporated herein by reference.

Respondent agrees to bear its own costs and attorney's fees related to this ESA. Failure by Respondent to pay the penalty assessed by this ESA and Final Order in full by its due date may subject Respondent to a civil action to collect the assessed penalty plus interest, attorney's fees, costs, and an additional quarterly nonpayment penalty pursuant to Section 309(g)(9)(B) of the Act, 33 U.S.C. § 1319(g)(9)(B). In any such collection action, the validity, amount, and appropriateness of the penalty shall not be subject to review. Pursuant to Section 309(g)(1) of the Act, 33 U.S.C. § 1319(g)(1), and 40 C.F.R. § 22.38(b), the State of Mississippi was provided a prior opportunity to consult with the EPA regarding this matter.

By signing this Agreement, Respondent certifies that: (1) the alleged violations listed in the Alleged Violations Form have been corrected, and Respondent has submitted true and accurate documentation to the EPA of such correction; and (2) consistent with Section 162(f)(1) of the Internal Revenue Code, 26 U.S.C. § 162(f)(1), Respondent will not deduct penalties paid under this Agreement for federal tax purposes.

This Agreement, upon incorporation into the Final Order and full satisfaction by the parties, shall be a complete and full resolution of Respondent's liability for federal civil penalties for the violations of the Permit and Section 301(a) of the Act, 33 U.S.C. § 1311(a), alleged in the Alleged Violations Form. This Agreement does not affect the right of the EPA or the United States to pursue appropriate injunctive or other

equitable relief or criminal sanctions for any violations of law or to issue an administrative compliance order, e.g., for any uncorrected violations listed in the Alleged Violations Form. Nothing in this Agreement shall relieve Respondent of the duty to comply with the Act and any regulation, order, or permit issued pursuant to the Act.

The EPA will provide public notice of this Agreement and a reasonable opportunity for the public to comment on the proposed issuance of this Agreement prior to issuance of the Final Order pursuant to Section 309(g)(4)(A) of the Act, 33 U.S.C. § 1319(g)(4)(A), and 40 C.F.R. § 22.45.

If Respondent does not sign and return this ESA as presented within 30 days of the date of its receipt, or within an extension timeframe approved by EPA, this proposed ESA is withdrawn without prejudice to EPA's ability to file any other enforcement action for the violations identified in the Alleged Violations Form.

The parties consent to service of this ESA and Final Order by e-mail to the e-mail addresses provided by the parties in the Certificate of Service.

This Agreement is binding on the parties signing below. Each person signing this Agreement certifies that he or she has the authority to sign for the party who he or she represents and to bind that party to its terms. The Expedited Settlement Agreement and Final Order are effective the date of filing with the Regional Hearing Clerk. Once the ESA is signed by the Regional Judicial Officer, the original ESA will be filed with the Regional Hearing Clerk. A copy of the filed ESA will be emailed to Respondent.

**ENCLOSURE A**  
**Wastewater Alleged Violations Form**

1. To accomplish the objective of the Clean Water Act (CWA), as defined in Section 101(a) of the CWA, 33 U.S.C. § 1251(a), to restore and maintain the chemical, physical, and biological integrity of the nation's waters, Section 301(a) of the CWA, 33 U.S.C. § 1311(a), prohibits the point source discharge of pollutants into navigable waters except as in compliance with a National Pollutant Discharge Elimination System (NPDES) permit issued pursuant to Section 402 of the CWA, 33 U.S.C. § 1342.
2. Section 402 of the CWA, 33 U.S.C. § 1342, establishes an NPDES Permit Program authorizing the EPA or authorized states to administer the NPDES Permit Program, including the issuance of NPDES permits allowing for the discharge of pollutants into navigable waters subject to specific terms and conditions. The EPA has granted the state of Mississippi through the Mississippi Department of Environmental Quality (MDEQ) approval to issue NPDES permits pursuant to Section 402(b) of the CWA.
3. The Town of French Camp (the Town) is a municipality in the State of Mississippi and is a "person" within the meaning of Section 502(5) of the CWA, 33 U.S.C. § 1362(5).
4. At all times relevant to this action, the Town owned and operated a Public Owned Treatment Works (POTW) located on Highway 413 and Natchez Trace, French Camp, Mississippi.
5. On January 30, 2020, MDEQ issued NPDES No. MS0044075 (Permit) to the Town. Under this Permit, the POTW is permitted to discharge "pollutants" from a "point source" into Poplar Creek, a "navigable water" as defined at Section 502(7) of the CWA, 33 U.S.C. § 1362(7). The Permit became effective on January 30, 2020, and expires on December 31, 2024.
6. Pursuant to 40 C.F.R. Part 122.41(l)(4)(i), the Town is required to comply with the conditions of its NPDES Permit.
7. The NPDES Permit number MS0044075, Permit Condition S-1, requires the Town to submit analytical results on an annual Discharge Monitoring Report (DMR) which are due each year by the 28th of January.
8. On June 2, 2022, the EPA inspected the French Camp (POTW) located at Highway 413 and Old Natchez Trace, French Camp, MS on June 2, 2022, for compliance with its NPDES permit and the Clean Water Act (CWA). The inspection findings indicated that the City of French Camp violated its NPDES permit. A review of the ICIS database showed that the permittee failed to submit DMR data for the period covering from December 2020 and

December 2021. The EPA inspector also observed no effluent flow measurement device installed at the plant. Failure to comply with the proper flow measurement is a violation of Permit Condition S-1, whereas the applicant shall submit a report which is due annually by the 28th of January detailing the volume of wastewater released for each discharge that occurred in that year.

9. On February 1, 2024, the EPA further discovered, through their ICIS database, that the Town's annual DMR analytical results had not been submitted for 2022 and 2023.

10. Based on the missing information in ICIS, inadequate flow measurement, review of additional information, and discussions between the Town and the EPA, the EPA has determined that the Town violated Section 301 of the CWA, 33 U.S.C. § 1311, for failing to comply with the Permit, which required the Town to submit annual DMRs by January 28, 2021, 2022 and January 28, 2023.

### **Expedited Settlement Agreement and Final Order Payment Instructions**

Payment shall be in a single payment, due no later than 30 calendar days from the effective date of the Final Order. If the due date for the payment falls on a weekend or federal holiday, then the due date is the next business day.
