ORDER ON MOTION TO REVISE DATE FOR EPA'S REPLY BRIEF

The July 13, 2012 "Order Granting Joint Motion to Cancel Hearing and for the Court to Issue an Initial Decision based on the Written Record" set due dates for the parties to file briefs on the penalty issues. By Order dated July 25, 2012, the due dates for the Complainant's Initial Brief and Respondent's Response Brief were extended by three days, and each of the parties timely filed their briefs.

By Motion dated September 4, 2012, Complainant requests an additional six days to file and serve a reply brief. Although the Motion does not indicate whether or not Respondent opposes it, an extension of time for only a few days to file the reply brief would not result in any prejudice to the Respondent in the circumstances of this case.

An extension of time may be granted under Section 22.7(b) of the Rules of Practice, which provides that the Presiding Officer may grant a motion requesting an extension of time for filing any document for good cause shown and after consideration of prejudice to the other parties. 40 C.F.R. § 22.7(b).

The Motion to Revise Date for EPA's Reply Brief is hereby **GRANTED** for good cause as stated in the Motion. Accordingly, Complainant shall file and serve its Reply Brief, and any accompanying affidavits, declarations, documents and memoranda, on or before **September 24**, **2012**.
