Respondent Fivestar Realty, Inc. respectfully requests an extension of time to complete alternative dispute resolution ("ADR") for the above-captioned matter with Judge Spencer T. Nissen. Complainant consents to Respondent's request.

On April 28, 2009, Judge Nissen entered an Order Initiating Alternative Dispute Resolution Process and Appointing Neutral. During the ADR conference on June 24, 2009, Complainant agreed to Respondent's submittal of ability to pay documentation pursuant to settlement of the matter. As a result, the parties agreed to and requested a thirty (30) day extension to allow for thorough review of the documentation and any other settlement proposals offered by the parties.
