Enclosed is a Consent Agreement and Final Order (CAFO) in the Matter of ExxonMobil Oil Corporation/Joliet Refinery, docket number CWA-05-2026-0010. By signature of the Regional Judicial Officer, this CAFO issued on May 27, 2026. Consistent with 33 U.S.C. § 1319(g)(5), this CAFO will become final and effective on June 29, 2026, which is 30 days after issuance. Please refrain from making payment prior to this effective date.

Pursuant to the CAFO, ExxonMobil Oil Corporation/Joliet Refinery must pay the civil penalty within 30 days of the effective date. Accordingly, the civil penalty in the amount of \$136,200 is due on July 27, 2026. The check with which you pay the civil penalty must display the case name: In the Matter of ExxonMobil Oil Corporation/Joliet Refinery and the docket number CWA-05-2026-0010.
