The Administrator or the Comptroller General (or any representative designated by either) shall have access for the purpose of audit and examination to any records, reports, or information of a grantee which are required to be maintained under subsection (a) or which are pertinent to any financial assistance under this title.		
Section 1445(c) of the federal Sate Drinking Water Act and the Debt Collection Improvement Act provide that whoever fails to allow the Administrator, the Comptroller General, or representatives of either, to enter and conduct any audit or inspection authorized by SDWA section 1445(b) shall be subject to a civil penalty of not to exceed \$32,500. (See 42 U.S.C. § 300j-4(c); 40 C.F.R. § 19.4)
